7	SECTION 2.	The City of Albuquerque Code of Resolutions § 6-5-2
8	(Resolution 25)	7-1978, as amended) designating public areas where drinking
9	alcohol is perm	nitted, is hereby amended as follows:
10	"(A) <u>For p</u>	urposes of the provisions contained in the Criminal Code
11	relating to drin	king in public, the consumption of alcohol liquors ("Alcoholic
12	Liquors") or be	er ("Beer"), as those terms are defined in Section 4-5-2 ROA
13	<u>1994, is prohib</u>	ited in all City parks except for tT]he following public park and
14	recreation area	s [are] designated as those [ <del>public areas</del> ] where the [ <del>drinking</del>
15	consumption]	of [ <del>alcoholic beverages will be</del> <u>Alcoholic Liquors or Beer is]</u>
16	permitted:

8	or designee. Drinking of alcoholic beverages at the Crossroads Pedestrian
9	Mall shall also be permitted pursuant to the liquor license held by
10	Albuquerque Plaza Partners d/b/a Hyatt Regency Albuquerque upon execution
11	by Albuquerque Plaza Partners of a revocable permit with the city. Carolino
12	Canyon Open Space:
13	(15) Elena Gallegos Open Space (Reservation Only); and
14	(16) Open Space Visitors Center.]
15	(B) [Notwithstanding the provisions of Subsection '(A)' above, Alcoholic
16	Liquors or Beer may be sold, served or consumed at any park, open space, or
17	other city recreation location, including but not limited to Civic Plaza or any
18	park hosting Summerfest, during special events if specifically permitted
19	pursuant to the terms of any Special Event Permit, Park Use Agreement, or
20	other valid permit issued by the City.] Alcoholic liquors may be sold, served of
21	consumed at [the Civic Auditorium, the Albuquerque Sports Stadium and]
22	such other municipal facilities where the city in the future obtains
23	governmental liquor licenses, only in accordance with the laws applicable to
24	governmental liquor licenses, the terms of any lease agreements between the
25	city and its tenants or facility users and such others reasonable rules,
26	regulations, and policies regarding said facilities as the city may adopt from
27	time to time.
28	(C) All other [developed] public park[s] and recreation areas not
29	designated in division (A) above will be posted as not permitting the drinking
30	of alcoholic beverages."
31	SECTION 3. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
32	clause, word or phrase of this resolution is for any reason held to be invalid or
33	unenforceable by any court of competent jurisdiction, such decision shall not

affect the validity of the remaining provisions of this resolution. The Council hereby declares that it would have passed this resolution and each section, paragraph, sentence, clause, word or phrase thereof irrespective of any provision being declared unconstitutional or otherwise invalid. SECTION 4. EFFECTIVE DATE. This resolution shall take effect five days after publication by title and general summary.
