The City Attorney [may be removed from office for cause by the Mayor with the concurrence of two-thirds of the entire membership of the Council after cause has been determined by the Inspector General.] [may only be removed from office for cause by the Mayor with the concurrence of two-thirds of the entire membership of the Council after cause has been determined by the Director of the Office of Internal Audit and Investigations.] [shall have an employment agreement with the City specifying the terms and conditions of employment including a provision for the early termination of employment and expiring at the end of the current Mayor's term. The Mayor may terminate this agreement at any time with an affirmative vote of five members of the Council. The Mayor or Councilors may serve as appointees to this Committee. The Mayor, with the Committee approval shall make a recommendation for hire to the full Council for the position of City Clerk. The appointment of the City Clerk shall require an affirmative vote of two-thirds of the entire membership of the Council.]
- 2. The City Clerk's appointment shall be for a term that coincides and terminates with the term of the Mayor [making the appointment] unless sooner removed as provided herein. [At the beginning of the term of the Mayor (even after reelection) the Mayor and Committee shall have 90 days to appoint or approve the position of City Clerk.]
