SUBJECT: Mayor's Recommendation of Award (ROA) for RFP No.: RFP-2021-141-AVI-RD "Rental Car Concessions at Albuquerque International Sunport"

The City of Albuquerque Aviation Department, in conjunction with the Department of Finance and Administrative Services, Purchasing Division, issued the subject solicitation.

The RFP was posted on the Purchasing E-Procurement, Bonfire website on February 7, 2021 and advertised in the Albuquerque Journal on February 7, 2021.

The City received a total of five (5) proposal responses. The five (5) proposals were deemed responsive and were routed to the Ad Hoc Evaluation Committee.

The Ad Hoc Evaluation Committee evaluated and scored the responses, in accordance with the evaluation criteria published in the RFP. After thoroughly reviewing and scoring the proposals received, the Ad Hoc Evaluation Committee found all vendors to be to be both responsive and qualified and recommends an award of contracts to Avis Budget Car Rental, LLC (ABRC), EAN Holdings, LLC (Enterprise), New Mexico Rental Car (Walser Holding Company, Inc.), Sixt Rent a Car, LLC, and The Hertz Corporation. I concur with this recommendation.

The City of Albuquerque's Aviation Department, Finance Division will manage this contract.

Cover Analysis

1. What is it?

Recommendation of Award: Recommendation of Award(s) (ROA) for RFP No.: RFP-2021-141-VI-RD "Rental Car Concessions at Albuquerque International Sunport"

2. What will this piece of legislation do?

Approve the Recommendation of Award(s) for the Rental Car Concession contracts at the Albuquerque International Sunport

3. Why is this project needed?

These contracts are needed to provide rental car services for travelers at the Albuquerque International Sunport.

4. How much will it cost and what is the funding source?

There is no cost to the City of Albuquerque for these services as the Rental Car Concessions contracts are a source of revenue for the Albuquerque International Sunport.

5. Is there a revenue source associated with this contract? If so, what level of income is projected?

Total projected revenues for this contract are expected to be \$10.4M in FY 2022. Projected revenues are made up of \$2.6M of fixed facility rents and \$7.8M of rental car privilege fees. Rental car privilege fees are primarily driven based on the Aviation Department's preliminary estimate of enplaned passengers for FY 2022.

6. What will happen if the project is not approved?

The current Rental Car Concessions contracts expire on June 30, 2021. If the Recommendation of Awards are not approved rental car services will not be available at the Albuquerque International Sunport.

7. Is this service already provided by another entity?

The current brands operating at the Sunport Airport are Alamo, Avis, Budget, Dollar, Enterprise, Hertz, National, Payless and Thrifty Rental Car Companies. In addition to these current brands, this ROA will allow Sixt and New Mexico Car Rental to operate at the Sunport. however, the current agreements expire June 30, 2021.

COMMENTS: The Aviation Department will be contracting with Rental Car Companies to provide rental car services for travelers at the Albuquerque International Sunport. The approved revenue budget for FY22 for Rental Car Concessions is \$8M; however, the revenue resulting from these contracts for FY22 is estimated at \$10.4M. Therefore, it is estimated that the revenue from these contracts will be above the budgeted revenue by \$2.4M.
