	24	WHEREAS, the City's Public Purchases Ordinance authorizes the City to					
	25	promulgate regulations, which it has done by creating separate regulations for					

its Purchasing Division, Department of Health, Housing, and Homelessness,

- 1 and Department of Municipal Development that should be reviewed and 2 updated to assist in more efficiently completing transitional and affordable housing development projects. 3 4 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 5 **ALBUQUERQUE:** 6 SECTION 1. ROA 1994, Section 5-5-3 is hereby amended to add the 7 following definition in alphabetical order: 8 § 5-5-3 DEFINITIONS. REQUEST FOR QUALIFICATIONS. A request for 9 submission used to evaluate a potential contractor's experience and 10 qualifications that demonstrate their ability to deliver the required product or 11 service. 12 SECTION 2. A new Section 5-5-18 is hereby added to the Public Purchases 13 Ordinance as follows: 14 § 5-5-18 REQUEST FOR QUALIFICATIONS. A Request for Qualifications 15 may be issued for the procurement of tangible personal property, services, or 16 construction to evaluate the qualifications of prospective contractors. An 17 award may then be made to the most qualified contractor, based on the 18 criteria established in the Request for Qualifications. If the Chief Procurement 19 Officer, Director of the Department of Health, Housing, and Homelessness, or 20 Director of the Department of Municipal Development, as applicable, 21 determines in writing that proceeding directly to award without a subsequent 22 Request for Bids or Request for Proposals is appropriate and is in the best 23 interest of the City, a two-step procurement process shall not be required. 24 SECTION 3. ROA 1994, Section 5-5-19(A) of the Public Purchases 25 Ordinance is hereby amended to add new subsections as follows: 26 § 5-5-19 APPROVAL OF CONTRACTS. 27 (A) The following contracts must be approved by the City Council: 28 (9) Contracts procured under § 5-5-20(FF), as follows:
  - (a) Any contract procured under § 5-5-20(FF) in an amount exceeding \$100,000 for a single project;
  - (b) Any amendment to a contract procured under § 5-5-20(FF) which causes the amount of that contract to exceed \$100,000; and

1	(c) Any supplement to a contract procured under § 5-5-20(FF)
2	previously approved by City Council shall require additional approval by City
3	Council if the contract is increased by over 20% of the amount previously

5	SECTION 4. ROA 1994, Section 5-5-20 of the Public Purchases Ordinance is
6	hereby amended to add the following exemption:
7	§ 5-5-20 EXEMPTIONS. (FF) Procurement of items of tangible personal
8	property, services, and construction utilizing funds appropriated from the
9	State Department of Finance and Administration Capital Outlay program and
10	general appropriations for affordable and transitional housing projects, which
11	comply with a transparent process developed in conjunction with the
12	Purchasing Division, the Department of Health, Housing, and Homelessness,
13	or the Department of Municipal Development, as applicable, in support of
14	affordable and transitional housing development. This process shall ensure
15	the fair and equitable treatment of all participants, maximize the efficient use
16	of public funds, and include appropriate safeguards to uphold the integrity,
17	quality, and transparency of the City's procurement system.
18	SECTION 5. REVIEW AND IMPROVE ESTABLISHED REGULATIONS AND
19	POLICIES FOR THE DEPARTMENT OF HEALTH, HOUSING, AND
20	HOMELESSNESS. The City shall undertake a review of Department of Health,
21	Housing, and Homelessness procurement regulations and established
22	policies relating to transitional and affordable housing development projects.
23	Based on these reviews, the Mayor shall initiate amendments or recommend
24	for Council approval amendments that would simplify and streamline
25	transitional and affordable housing development projects. These processes
26	shall be completed, and an update provided to the Council via Executive
27	Communication no later than 30 days following the enactment of this
28	legislation.
29	SECTION 6. REVIEW AND IMPROVE ESTABLISHED REGULATIONS AND
30	POLICIES FOR THE DEPARTMENT OF MUNICIPAL DEVELOPMENT. The City
31	shall undertake a review of Department of Municipal Development
32	procurement regulations and established policies relating to transitional and

development projects. These processes shall be completed, and an update
provided to the Council via Executive Communication no later than 30 days
following the enactment of this legislation.
SECTION 7. SEVERABILITY. If any section, paragraph, sentence, clause,
word or phrase of this Ordinance is for any reason held to be invalid or
unenforceable by any court of competent jurisdiction, such decision shall not
affect the validity of the remaining provisions of this Ordinance. The Council
hereby declares that it would have passed this Ordinance and each section,
paragraph, sentence, clause, word or phrase thereof irrespective of any
provision being declared unconstitutional or otherwise invalid.
SECTION 8. COMPILATION. SECTIONS 1, 2, 3, and 4 of this Ordinance
amends, is incorporated in, and is to be compiled as part of the Revised
Ordinances of Albuquerque, New Mexico, 1994.
SECTION 9. EFFECTIVE DATE. This Ordinance takes effect five days after
publication by title and general summary.
