2 REPEALING ORDINANCES RELATED TO BOARDS AND/OR COMMISSIONS
3 AND/OR COMMITTEES THAT ARE NO LONGER IN EFFECT (ROA 1994 §§ 2-6-3
4 (INFORMATION SERVICES COMMITTEE), 2-6-13 (THE CENTRAL AVENUE
5 BUSINESS ADVISORY BOARD), 9-1-1 (COMMISSION ON ALCOHOL AND
6 SUBSTANCE ABUSE), 10-10-1 (BALLOON FIESTA PARK COMMISSION), AND
7 14-5-6-10 (APPEALS; TECHNICAL STANDARDS COMMITTEE)); ADDING A
8 NEW SECTION 2-6-21-1 ET SEQ TO CREATE “THE GAATC AND GARTC
9 MERGING TASK FORCE”; AND AMENDING SELECTION ADVISORY
10 COMMITTEE § 14-7-2-3(A)(2).

15 **WHEREAS, the Task Force further recommended dissolution, restructuring,**
16 **or consolidation of certain entities to reduce duplication, improve**
17 **coordination, and strengthen advisory effectiveness; and**

22 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
23 ALBUQUERQUE:

1 SECTION 2. The “Central Avenue Business Advisory Board”, ROA 1994 § 2-
2 6-13 et seq., is repealed in its entirety.

3 SECTION 3. The “Commission on Alcohol and Substance Abuse”, ROA
4 1994 § 9-1-1 et seq., is repealed in its entirety.

5 SECTION 4. The “Balloon Fiesta Park Commission”, ROA 1994 § 10-10-1 et
6 seq., is repealed in its entirety.

7 SECTION 5. The “Technical Standards Committee” under ROA 1994 § 14-5-
8 6-10 is repealed in its entirety.

9 SECTION 6. A new subsection is added starting at § 2-6-21-1 to create “The
10 GAATC and GARTC Merging Task Force” as follows:

11 [Part 21: GAATC and GARTC Merging Task Force

12 §2-6-21-1: Short Title.

13 Sections 2-6-21-1 et seq. may be cited as the “GAATC and GARTC Task
14 Force.”

15 §2-6-21-2: Composition.

16 The Task Force shall consist of seven voting members who are
17 representative of the GAATC and the GARTC equally. Task Force membership
18 shall be decided as follows:

19 (A) Three members shall be appointed to the task force by and of the
20 membership of the GAATC.

21 (B) Three members shall be appointed to the task force by and of the
22 membership of the GARTC.

23 (C) The seventh member of the Task Force shall be appointed and
24 approved by the six members of the Task Force as appointed by the two
25 boards. The seventh member shall serve as the chairperson of the task force
26 and does not have to be a sitting member of either board.

27 §2-6-21-3: Duties and Responsibilities.

28 The Task Force shall review the governing documents of both the GAATC
29 and GARTC. This review shall consist of a thorough analysis of membership,
30 responsibilities, legal authorities, effectiveness and structure.

31 The Task Force shall prepare a report and recommendation to the
32 administration and City Council by no later than July of 2026 outlining a

1 workplan to merge the GAATC and GARTC into one city board. This
2 recommendation shall include, but may not be limited to:

3 (A) Name of the newly merged board; and

4 (B) Membership requirements of the board to include how to incorporate
5 members from both boards; and

6 (C) Duties and responsibilities of the board; and

7 (D) The Task Force shall identify the appropriate City department to be
8 associated with each newly recommended board and shall submit proposed
9 ordinance or resolution language to establish the board.

10 (E) Goals and objectives of the board.

11 §2-6-21-4: Meetings and Procedures.

12 (A) The Task Force shall convene its first meeting within 45-days after
13 appointments have been made. Following its initial meeting, the Task Force
14 may set its own meeting schedule.

15 (B) The Task Force shall elect the seventh member, the chairperson, of the
16 task force, by its second meeting.

17 (C) A quorum of the Task Force shall consist of a majority of its members.

18 (D) The Transit Department shall provide necessary administrative support
19 and resources for the Task Force to fulfill its duties. Both the Transit
20 Department and the Department of Parks and Recreation shall provide the
21 GAATC and the GARTC with support with appointment of membership to the
22 Task Force.

23 (E) The Task Force shall meet as necessary in order to provide the required
24 report to the Administration and City Council by July of 2026.

25 §2-6-21-5: Sunset Provision

26 The Task Force shall be dissolved upon completion and submission of the
27 required report.]

28 SECTION 7. The "Selection Advisory Committee" § 14-7-2-3(A)(2) is
29 amended as follows:

30 [(2) Three city employees, ~~[two of whom are]~~ [one who is] registered in
31 the state as [an] architect. ~~[, the other two having similar or construction,~~
32 engineering, or design/build experience.]

1 **SECTION 8. SEVERABILITY.** If any section, paragraph, sentence, clause, word
2 or phrase of this Ordinance is for any reason held to be invalid or
3 unenforceable by any court of competent jurisdiction, such decision shall not
4 affect the validity of the remaining provisions of this Ordinance. The Council
5 hereby declares that it would have passed this Ordinance and each section,
6 paragraph, sentence, clause, word, or phrase thereof, irrespective of any
7 provision being declared unconstitutional or otherwise invalid.

8 **SECTION 9. COMPILATION.** SECTIONS 1 through 7 of this Ordinance are
9 incorporated in and are to be complied with as part of the Revised Ordinances
10 of Albuquerque, New Mexico, 1994.

11 **SECTION 10. EFFECTIVE DATE.** This Ordinance takes effect five days
12 after publication by title and general summary.
