1 RESOLUTION

2 APPROVING AND AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS
3 BASED ON THE ATTACHED NOTICE OF GRANT AWARD FOR A SENIOR
4 COMPANION PROGRAM GRANT WITH THE CORPORATION FOR NATIONAL
5 AND COMMUNITY SERVICE AND THE NEW MEXICO AGING AND LONG TERM
6 SERVICES DEPARTMENT AND PROVIDING FOR AN APPROPRIATION TO THE
7 DEPARTMENT OF SENIOR AFFAIRS SENIOR COMPANION PROGRAM IN
8 FISCAL YEAR 2016.

9 WHEREAS, the 2010 census figures show that there are 207,179 persons
10 age 50 years and over living in Bernalillo County which represents 18% of the
11 County's population; and

12 WHEREAS, the Albuquerque Department of Senior Affairs has developed a
13 coordinated delivery system of services that meets the needs of senior
14 citizens within the City of Albuquerque and Bernalillo County; and

15 WHEREAS, The Corporation for National and Community Service has
16 allocated funds in the amount of \$99,827 and the New Mexico Aging and Long
17 Term Services Department has allocated funds in the amount of \$93,470 to the
18 Department of Senior Affairs to meet these needs through the continued
19 programming of the Senior Companion Program; and

20 WHEREAS, the City of Albuquerque is desirous of applying for these funds
21 and contribute matching funds of \$92,510 City funds, which consists of
22 \$14,350 for indirect costs and \$78,160 City cash match; and

23 WHEREAS, the total cost of the project is \$285,807.

24 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
25 ALBUQUERQUE:

1 **Section 1: The Mayor is authorized to take all necessary and appropriate**
2 **steps to enter into a grant agreement with the Corporation for National and**
3 **Community Service and the New Mexico Aging and Long Term Services**
4 **Department for the Senior Companion Program in the amount of \$193,297**
5 **consisting of \$99,827 of Federal funds, and \$93,470 of State of New Mexico**
6 **funds.**

7 **Section 2: Funds in the amount of \$285,807 consisting of \$99,827 from the**
8 **Corporation for National and Community Service, \$93,470 from the New**
9 **Mexico Aging and Long Term Services Department and \$92,510 of City**
10 **matching funds from the Transfer to Operating Grants Fund Program in the**
11 **General Fund (110) are hereby appropriated to the Department of Senior**
12 **Affairs in the Operating Grants Fund (265) for the Senior Companion Program**
13 **for fiscal year 2016.**

14 **Section 3: Of the \$92,510 from the Transfer to Operating Grants Program in**
15 **the General Fund (110), \$14,350 is for indirect overhead.**




