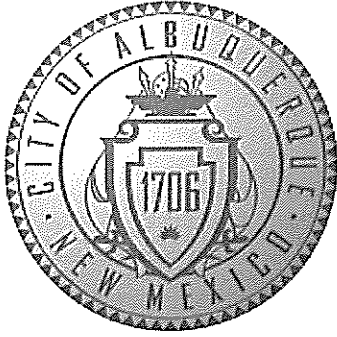

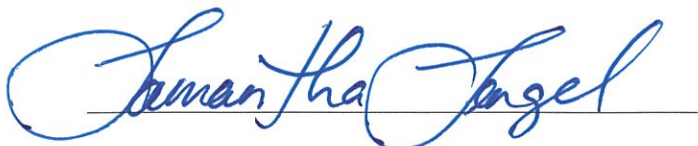
A resident of Council District 5, Mrs. Valarie L. Thietten will serve as the At Large representative on the board; her first term will expire on March 1, 2027.
