1 WHEREAS, the Open Meetings Act was established with the intent of
2 ensuring that policy decisions affecting the public are made in a transparent
3 and open manner, to serve the best interests of all residents of New Mexico;

4 WHEREAS, adherence to the Open Meetings Act is essential to the
5 preservation of a free society and the democratic process, as it is crucial for a
6 policymaking body to maintain the trust of the public; and

7 WHEREAS, a significant portion of the Air Board comprises individuals
8 advocating for specific interests rather than a diverse representation of experts
9 in the relevant subject matter; and

10 WHEREAS, historically, the Air Board has strived to include members with
11 backgrounds in the fields of medicine, science, industry, advocacy, law, and
12 technical academia; and

13 WHEREAS, it is imperative to maintain a composition that reflects the
14 diverse expertise required for the comprehensive consideration of pertinent
15 matters.

16 BE IT ORDAINED BY THE COUNCIL, GOVERNING BODY OF THE CITY OF
17 ALBUQUERQUE:

18 SECTION 1. REPEALER. Chapter 9, Article 5, Part 1 is hereby repealed.

19 SECTION 2. NEW MATERIAL. Chapter 9, Article 5, Part 1 is hereby added to read
20 as follows:

21 "PART 1: AIR QUALITY CONTROL BOARD

22 § 9-5-1-1 SHORT TITLE.

23 Sections 9-5-1-1 et seq. may be cited as the "Joint Air Quality Control Board
24 Ordinance."

25 § 9-5-1-2 DEFINITIONS.

26 As provided in the New Mexico Air Quality Control Act, Sections 74-2-1 through
27 74-2-17 NMSA 1978 (hereinafter referred to as the "Air Quality Control Act"), the
28 following definitions shall apply to terms used in §§ 9-5-1-1 et seq.

29 AIR CONTAMINANT. Any substance, including but not limited to any
30 particulate matter, fly ash, dust, fumes, gas, mist, smoke, vapor,
31 microorganisms, radioactive material, any combination thereof or any decay or
32 reaction product thereof.

1 AIR POLLUTION. The emission, except emission that occurs in nature, into
2 the outdoor atmosphere of one or more air contaminants in quantities and of a
3 duration that may with reasonable probability injure human health or animal or
4 plant life or as may unreasonably interfere with the public welfare, visibility or
5 the reasonable use of property.

6 BOARD. The Albuquerque-Bernalillo County Air Quality Control Board
7 created by §§ 9-5-1-1 et seq.

8 DEPARTMENT. The administrative agency that is the local agency under the
9 Air Quality Control Act of the Albuquerque-Bernalillo County Air Quality Control
10 Board.

11 DIRECTOR. The administrative head of the Department or his or her
12 authorized representative.

13 EMISSION LIMITATION and EMISSION STANDARD. A requirement
14 established by the Board, the Department, or pursuant to the federal Act that
15 limits the quantity, rate or concentration, or combination thereof, of emissions
16 of air contaminants on a continuous basis, including any requirements relating
17 to the operation or maintenance of a source to assure continuous reduction.

18 ENVIRONMENT DEPARTMENT. The Environment Department of the state.

19 EX PARTE COMMUNICATION. An oral or other communication with a board
20 member, a board hearing officer, or board attorney regarding the merits of an
21 expected or pending petition or related proceeding if:

22 (1) the communication is made by a person, including a board member,
23 hearing clerk, hearing officer, or board attorney;

24 (2) the person communicating knows or has reason to know a petition
25 will be or has been filed for a hearing before the Board;

26 (3) the communication is made without all other parties to the proceeding
27 being present or receiving the same communication received by the board
28 member, board hearing officer, or board attorney, except where authorized by
29 the closed meeting provisions of the Open Meetings Act; and

30 (4) the communication is intended to affect, or reasonably may be
31 expected to affect the board member's, board hearing officer's, or board
32 attorney's opinion regarding the merits of the expected or pending petition or
33 related proceeding.

1 FEDERAL ACT. The Federal Clean Air Act, 42 U.S.C. 7401 through 7642, its
2 subsequent amendments and successor provisions.

3 FEDERAL STANDARD OF PERFORMANCE. Any standard of performance,
4 emission limitation or emission standard adopted pursuant to 42 U.S.C. Section
5 7411 or 7412.

6 HAZARDOUS AIR POLLUTANT. An air contaminant that has been classified
7 as a hazardous air pollutant pursuant to the Federal Act.

8 MANDATORY CLASS I AREA. Any of the following areas in the state of New
9 Mexico that were in existence on August 7, 1977:

10 (1) National wilderness areas that exceed 5,000 acres in size; and

11 (2) National parks that exceed 6,000 acres in size.

12 MAYOR. The Mayor or his or her authorized representative.

13 MODIFICATION. Any physical change in, or change in the method of
14 operation of a source that results in an increase in the Potential Emission Rate
15 of any Regulated Air Contaminant emitted by the source or that results in the
16 emission of any Regulated Air Contaminant not previously emitted, but does
17 not include:

18 (1) A change in ownership of the source;

19 (2) Routine maintenance, repair or replacement;

20 (3) Installation of air pollution control equipment and all related process
21 equipment and materials necessary for its operation, undertaken for the
22 purpose of complying with regulations adopted by the board or pursuant to the
23 Federal Act; or

24 (4) Unless previously limited by enforceable permit conditions:

25 (a) An increase in the production rate, if such increase does not exceed
26 the operating design capacity of the source;

27 (b) An increase in the hours of operation; or

28 (c) Use of an alternative fuel or raw material if, prior to January 6, 1975,
29 the source was capable of accommodating such fuel or raw material, or if use
30 of an alternate fuel or raw material is caused by any natural gas curtailment or
31 emergency allocation or any other lack of supply of natural gas.

1 **NONATTAINMENT AREA.** For any air contaminant, an area that is designated
2 “nonattainment” with respect to that contaminant within the meaning of Section
3 107(d) of the Federal Act.

4 **PERSON.** An individual, partnership, corporation, association, the state or
5 political subdivision of the state or any agency, department, or instrumentality
6 of the United States and any of their officers, agents or employees.

7 **PLAN.** Any and all parts of the state implementation plan~~t~~ that pertain to the
8 county that are adopted by the Board for submittal by the Governor of the state
9 to the federal Environmental Protection Agency pursuant to 42 U.S.C. Section
10 7410.

11 **POTENTIAL EMISSION RATE.** The emission rate of a source at its maximum
12 capacity in the absence of air pollution control equipment that is not vital to
13 production of the normal product of the source or to its normal operation; also
14 defined by Board regulations as “pre-controlled” emissions.

15 **REGULATED AIR CONTAMINANT.** Any air contaminant, the emission or
16 ambient concentration of which is regulated pursuant to the Air Quality Control
17 Act or the Federal Act.

18 **SIGNIFICANT DETERIORATION.** Any increase in the ambient concentrations
19 of any air contaminant above the levels allowed by the Federal Act or Federal
20 regulations for that air contaminant in the area within which the increase
21 occurs.

22 **SOURCE.** Any structure, building, equipment, facility, installation or
23 operation that emits or may emit any air contaminant.

24 **STANDARD OF PERFORMANCE.** A requirement of continuous emission
25 reduction, including any requirement relating to operation or maintenance of a
26 source to assure continuous emission reduction.

27 **STATE IMPLEMENTATION PLAN.** Any plan submitted by the Governor of the
28 state of New Mexico to the federal Environmental Protection Agency pursuant
29 to 42 U.S.C. Section 7410.

30 **§ 9-5-1-3 JOINT AIR QUALITY CONTROL BOARD.**

31 **(A)** In accordance with the New Mexico Air Quality Control Act, a joint air
32 quality control board known as the Albuquerque-Bernalillo County Air Quality
33 Control Board is created. The Board shall serve as a joint local authority acting

1 on behalf of both the city and the county. Within the exterior boundaries of the
2 county, the Board shall have authority and jurisdiction to exercise the same
3 functions pertaining to air quality as the functions that have been delegated by
4 the Air Quality Control Act to the New Mexico Environmental Improvement
5 Board except any functions reserved exclusively for the Environmental
6 Improvement Board.

7 (B) The membership and organization of the Board shall be as described
8 in this section.

9 ~~(1) Members of the Board previously appointed and serving at the time~~
10 ~~§§9-5-1-1 et seq. are enacted shall continue serving their terms on the Board.~~
11 ~~The length and termination date of their terms of office shall not be affected by~~
12 ~~the passage of §§ 9-5-1-1 et seq.~~

13 ~~(2)~~(1) The Board shall consist of seven members, four of whom shall be
14 appointed by the Mayor with the advice and consent of the City Council and
15 three of whom shall be appointed by the County Commission. The Mayor shall
16 submit qualified appointments to City Council within 30 days of the effective
17 date. If the Mayor does not timely submit qualified persons for appointment,
18 City Council may appoint the initial members of the Board.

19 ~~(3)~~(2) Members shall be appointed for three-year terms. No member shall
20 serve more than two consecutive terms at a time. If a person is appointed to fill
21 an unexpired term of another member, that term shall be considered a term for
22 the purpose of this limitation. The positions on the Board shall be staggered
23 appointments so no more than two city appointee's terms expire in any single
24 year. Vacant positions shall be filled by individuals appointed by the same
25 authority that appointed the outgoing member.

26 ~~(4)~~(3) Nominations and appointments to the Board shall be made as follows:

27 (a) At least a majority of the membership of the Board shall be individuals
28 who represent the public interest and meet the requirements of the state and
29 federal guidelines set forth in the New Mexico Air Quality Control Act, as
30 amended, and the federal Clean Air Act, 42 U.S.C.A. Section 7401, et seq., as
31 amended. Further, to the extent that the requirement does not conflict with this
32 division (a), Board members will be selected as follows: one Board member
33 shall be a registered professional licensed engineer who shall have at least five

1 (5) years' experience in the field of air pollution control; one Board member
2 shall be a physician licensed in New Mexico who shall be experienced in the
3 health effects of air contaminants; one Board member shall be a person

5 in the conducting of training in air pollution evaluation and control; and one
6 Board member shall be a person from City industry with current full-time
7 employment in a private manufacturing concern and have a college degree and
8 8 years of combined technical training and experience in permit compliance or
9 air pollution abatement for Title 5 or non-Title 5 sources for a source permitted
10 in the city or county. ~~for their concerns about, and commitment to, the local~~
11 ambient air quality. Therefore, selections may be made from a broad range of
12 persons representing the public interest and who are experienced or trained in
13 disciplines including natural sciences, humanities, social studies, finance,
14 medicine and health, engineering or physics, law, law enforcement, education,
15 business and industry.As used in this section: REPRESENT THE PUBLIC
16 means does not have a controlling interest in, have 5 percent or more of his or
17 her capital invested in, serve as attorney for, act as consultant for, serve as
18 officer or director of, or hold any other official or contractual relationship with
19 any person subject to permits or enforcement orders or any trade or business
20 association of which such a person is a member; SIGNIFICANT PORTION OF
21 INCOME means 10 percent or more of gross personal income for a calendar
22 year, including retirement benefits, consultant fees, and stock dividends,
23 except that it shall mean 50 percent or more of gross personal income for a
24 calendar year if the recipient is over 60 years of age and is receiving such
25 portion pursuant, to retirement, pension, or singular arrangement. Income
26 derived from mutual-fund payments, or from other diversified investments as
27 to which the recipient does not know the identity of the primary sources of
28 income, shall be considered part of the recipient's gross personal income but
29 shall not be treated as income derived from persons subject to permits or
30 enforcement orders; and PERSONS SUBJECT TO PERMITS OR
31 ENFORCEMENT ORDERS includes any individual, corporation, partnership, or
32 association who holds, is an applicant for, or is subject to any permit, or who is
33 or may become subject to any enforcement order under the Federal Clean Air

1 Act, Air Quality Control Act, any regulation of the Board or any permit condition
2 issued thereto, except that it does not include (1) an individual who is or may
3 become subject to an enforcement order solely by reason of his or her
4 ownership or operation of a motor vehicle or (2) any department or agency of,
5 a state, local or regional government.

6 (b) No person employed on a full time basis by either the city or the
7 county shall be a member of the Board. No elected city or county official, and
8 no member of the immediate family of any elected city or county official shall
9 be appointed to the Board.

10 (c) Members shall submit to the Department a signed written statement
11 to assure compliance with the applicable law on Board composition, upon
12 appointment and renewed annually or with any change in employment, and
13 such statement shall be available for public inspection. -In the event either the
14 Department cannot make a finding that at least a majority of the Board as
15 constituted by appointment of its members meets the requirements of
16 applicable law, the Department shall notify the City Council and the County
17 Commission of the determination that at least a majority of its membership does
18 not meet the requirements. The Department shall advise and make
19 recommendations regarding corrective action necessary to allow the Board to
20 be qualified under applicable law, including substitutionary appointments of a
21 member or members. The Board shall not act to hear petitions of permit
22 appeals, variances, or regulatory changes until the City Council and County
23 Commission have both determined that it can do so consistent with applicable
24 law.

25 ~~(c)~~(d) City-appointed members shall be residents of the city and
26 county-appointed members shall be residents of the county.

27 ~~(d)~~(e) A Board member may be removed from office by the appointing
28 authority if:

29 (i) The appointing authority determines the member has violated any law,
30 regulation, or ordinance, or for other good cause such as malfeasance or the
31 intentional failure to carry out the duties of the Board, or is otherwise incapable
32 or unfit to discharge the duties of the office;

33 (ii) the member has missed three consecutive meetings or has been

1 absent from more than 50% of the meetings during any 12 consecutive
2 meetings; or

3 (iii) to comply with the requirements of division (B)(3)(a) for member

5 (f) At least two months before a Board member's term expires, the
6 Department shall solicit a recommended list of qualified members for the city
7 vacancy as suggested by the City Council and the Department for consideration
8 by the Mayor. The County Commission will appoint its representatives to the
9 Board. The list shall include a brief biography describing the qualifications of
10 each candidate. From the list, as modified or enlarged by the appointing
11 authority, appointments to the Board will be made.

12 (g) Candidates appointed shall be notified in writing, and the candidate
13 must accept or reject the appointment in writing.

14 (e)(h) Unless a member retires or is removed, each member shall
15 serve until a successor has been appointed.

16 (i) If a vacancy occurs for reasons other than expiration of a term, the
17 Department shall promptly utilize the procedure described in division (e) above.
18 Each vacancy shall be filled by the authority that appointed the departing
19 member. The replacement member shall serve for the remainder of the
20 unexpired term.

21 (5)(4) Four members present shall constitute a quorum. A quorum shall be
22 present for all matters decided by a vote of the Board.

23 (6)(5) Any action, order or decision of the Board requires a simple majority
24 vote of the members present, except for adoption, amendment or repeal of a
25 Board regulation, in which case the concurrence of four members shall be
26 required.

27 (7)(6) All officers of the Board shall be elected annually by the Board for
28 one-year terms. No officer shall serve in the same position for more than two
29 consecutive years at a time.

30 (8)(7) The Board may adopt rules to govern its proceedings. Such rules shall
31 not take effect until reviewed and approved by the City Attorney and County
32 Attorney.

33 (C) The Board shall meet in public facilities with public seating available.

1 (D) The Board shall meet monthly if a quorum is available unless a
2 meeting is unnecessary or delayed for good reason. The Board shall hold a
3 minimum of six monthly meetings a year. Special additional meetings may be
4 held as needed.

5 (E) Notice of time, place and agenda of meetings, work sessions,
6 committee meetings, hearings, any other gathering of a quorum of the Board,
7 and subcommittee meetings shall be published according to the requirements
8 of law, including the Open Meetings Act. Meetings, work sessions, committee
9 meetings, and hearings and any other gathering of a quorum of the Board, and
10 subcommittee meetings shall be open to the public and shall follow the
11 procedures described in the Open Meetings Act.

12 ~~(C)~~(F) In addition to any requirements applicable to each member based on
13 the member's appointing authority as set forth in the City and County codes of
14 conduct, any member of the Board who has a conflict of interest regarding a
15 matter before the Board shall disqualify himself or herself from the discussion
16 and shall abstain from the vote on such matter. If a potential conflict of interest
17 is raised during a meeting a member of the board shall submit the question to
18 the entire Board for a determination of whether disqualification is necessary.
19 The member with the potential conflict being voted on shall not vote in this
20 determination. The Board's determination of whether disqualification is
21 necessary shall be final. In the event a member is made aware of a conflict of
22 interest requiring disqualification or abstention outside of a meeting, the
23 member shall disclose the potential conflict of interest to the board and may
24 seek guidance concerning disqualification from the board attorney or seek an
25 advisory opinion from the County or City, as applicable to each member based
26 on the member's appointing authority. A conflict of interest means any interest
27 which may yield, directly or indirectly any monetary or other material benefit to
28 the Board member or the member's spouse or minor child.

29 (G) The City Environmental Planning Commission (EPC) and the County
30 Planning Commission (CPC) may appoint a member of the EPC and of the CPC,
31 respectively, to be liaisons to the Air Quality Control Board. The EPC and CPC
32 liaisons may attend Board meetings and may participate in Board discussions,
33 but will not be members of the Board and will not vote. The respective liaisons

1 may communicate with the Board and their respective planning commissions
2 regarding air quality issues.

3 (H) The eCity shall provide the staffadministrative support it deems
4 necessary to the Board to assist the Board with carrying out the administrative
5 functions of its powers and duties under the Air Quality Control Act. Nothing
6 herein shall limit the city’s authority and ability to maintain full oversight and
7 control over such staffCity resources.

8 (1) The Director of the Department~~The Department shall attend all~~
9 meetings of the Board, but not be entitled to a vote. The Department shall record
10 all transactions and proceedings of the Board~~and shall perform the duties~~
11 required by the Air Quality Control Act. The Department shall handle
12 correspondence, keep records, prepare reports, and perform such other duties
13 as the city may direct or authorize to carry out the administrative functions of
14 the city and Board’s powers and duties under the Air Quality Control Act.

15 (2) The Director is the custodian of all files and records of the Board and
16 the Board shall provide such files and records to the Director upon request.

17 ~~(1)~~(3) The Director, and shall be an ex officio member of the Board and may
18 meet with the Board, but does not have a vote. Nothing herein limits or waives
19 ex parte communication prohibitions which shall apply to the Director.

20 (4) Staff may be an employee of the city but shall not include such
21 employee’s supervisory staff.

22 (5) In the exercise of any of its powers or duties, the Board may act with
23 legal advice received in accordance with the Open Meetings Act, Chapter 10,
24 Article 15, NMSA 1978. Such legal advice shall be provided by the city. Such
25 legal research shall be distributed to all Board members. Legal advice and legal
26 research shall only be requested with the concurrence of four Board members.
27 An attorney to the Board shall not be a member of the Board or serve as an ex-
28 officio member, and shall act only in an advisory capacity. The Board shall not
29 delegate its authority to the Board’s attorney.

30 § 9-5-1-4 DUTIES AND POWERS OF BOARD.

31 (A) The Board, in accordance with the Air Quality Control Act, shall
32 prevent or abate Air Pollution within the city and county.

33 (B) The Board shall:

1 (1) Adopt, promulgate, publish, amend and repeal regulations consistent
2 with the Air Quality Control Act and §§9-5-1-1 et seq. to attain and maintain
3 national ambient air quality standards and prevent or abate air pollution,
4 including regulations prescribing air standards, within the geographic area of
5 the Board’s jurisdiction, or any part thereof; and

6 (2) Adopt a plan for the regulation, control, prevention or abatement of
7 Air Pollution, recognizing the differences, needs, requirements and conditions
8 within the county or any part thereof.

9 (C) Regulations adopted by the Board may:

10 (1) Include regulations to protect visibility in Mandatory Class I Areas, to
11 prevent significant deterioration of air quality and to achieve national ambient
12 air quality standards in nonattainment areas, provided that such regulations:

13 (a) shall be no more stringent than but at least as stringent as required
14 by the Federal Act and federal regulations pertaining to visibility protection in
15 Mandatory Class I Areas, pertaining to prevention of significant deterioration
16 and pertaining to nonattainment areas; and

17 (b) Shall be applicable only to sources subject to such regulation
18 pursuant to the Federal Act;

19 (2) Prescribe standards of performance for Sources and Emission
20 Standards for Hazardous Air Pollutants that, except as provided in division (3)
21 below:

22 (a) Shall be no more stringent than but at least as stringent as required
23 by federal standards of performance; and

24 (b) Shall be applicable only to sources subject to such federal standards
25 of performance;

26 (3) Include regulations governing emissions from solid waste
27 incinerators that shall be as least as stringent as, and may be more stringent
28 than, any applicable federal emission limitations;

29 (4) Require notice to the Department of the intent to introduce or allow
30 the introduction of an air contaminant into the air within the geographical area
31 of the Board’s jurisdiction; and

32 (5) Require any person emitting any air contaminant to:

33 (a) Install, use and maintain emission monitoring devices;

1 (b) Sample emissions in accordance with methods and at locations and
2 intervals as may be prescribed by the Board;

3 (c) Establish and maintain records of the nature and amount of

6 the performance of emission control devices; and

7 (e) Provide any other reasonable information relating to the emission of
8 air contaminants.

9 (D) Any regulation adopted under this section shall be consistent with
10 federal law, if any, relating to control of motor vehicle emission.

11 (E) In making its regulations, the Board shall give weight it deems
12 appropriate to all facts and circumstances, including but not limited to:

13 (1) Character and degree of injury to or interference with health, welfare,
14 visibility and property;

15 (2) The public interest, including the social and economic value of the
16 Sources and subjects of air contaminants; and

17 (3) Technical practicability and economic reasonableness of reducing or
18 eliminating air contaminants from the Sources involved and previous
19 experience with equipment and methods available to control the air
20 contaminants involved.

21 **§ 9-5-1-5 DUTIES AND POWERS OF THE DEPARTMENT.**

22 The Department shall:

23 (A) Administer and enforce the provisions of the Air Quality Control Act,
24 §§9-5-1-1 et seq. and any regulations adopted pursuant thereto and any other
25 laws relating to Air Pollution applicable within the city and the county. ~~The staff~~
26 ~~for the Board shall be provided by the city.~~ The Department shall perform, within
27 the boundaries of the county, all functions delegated to the New Mexico
28 Environment Department under the Act, except for the duties and powers
29 reserved exclusively for the Environment Department.

30 (B) Develop facts and make investigations and studies consistent with
31 the Air Quality Control Act and §§9-5-1-1 et seq., and in connection therewith,
32 enter at all reasonable times in or upon any private or public property, except
33 private residences, that the Department has reasonable cause to believe is or

1 will become a source of air contaminants contributing to air pollution and
2 require the production of information relating to emissions that cause or
3 contribute to air pollution. The results of any such investigations shall be
4 reduced to writing if any enforcement action is contemplated, and a copy
5 thereof shall be furnished to the owner or occupant of the premises before the
6 action is filed.

7 (C) Institute legal proceedings to compel compliance with the Air Quality
8 Control Act, §§9-5-1-1 et seq., or any regulation of the Board.

9 (D) Encourage and make every reasonable effort to obtain voluntary
10 cooperation by the owner or occupants to preserve, restore or improve air
11 purity.

12 (E) Consult with any person proposing to construct, install or otherwise
13 acquire an air contaminant source, device, system or control mechanism
14 concerning the efficiency of the device, system, or mechanism or the air
15 pollution problem that may be related to the source, device, system or
16 mechanism, provided that consultation shall not relieve any Person from

- 8 (4) Set forth the particular provisions of §§ 9-5-1-1 et seq. sought to be
9 enforced;
- 10 (5) Set forth any other reason necessitating the inspection, including
11 knowledge or belief that a particular condition exists in the premises, or portion
12 thereof, which constitutes a violation of §§ 9-5-1-1 et seq.; and
- 13 (6) State that the Department Mayor—or the Department’s Mayor’s
14 designated representative is authorized by the city Mayor to make the
15 inspection.

16 § 9-5-1-15 REPRESENTATION OF THE DEPARTMENT, THE CITY AND THE
17 COUNTY.

18 In any court action to enforce the provisions of the Air Quality Control Act, §§
19 9-5-1-1 et seq. or any regulation, permit condition or emergency order adopted,
20 imposed or issued pursuant thereto:

- 21 (A) The city and the Department shall be represented by the City Attorney;
22 and
- 23 (B) The County or City Attorney shall be represented by the District
24 Attorney.

25 § 9-5-1-98 VIOLATIONS; COMPLIANCE ORDERS; FIELD CITATIONS.

26 (A) Whenever, on the basis of any information, the Mayor Director
27 determines that any person has violated or is violating any requirement, or
28 prohibition of the Air Quality Control Act, §§ 9-5-1-1 et seq., any regulation
29 promulgated pursuant to §§ 9-5- 1-1 et seq., or any condition of a permit issued
30 pursuant thereto, the Director Mayor may:

- 31 (1) Issue a compliance order stating with reasonable specificity the
32 nature of the violation and requiring compliance immediately or within a
33 specified time period or assessing a civil penalty for any past or current

1 violation, or both; or

2 (2) Commence a civil action in district court for appropriate relief,
3 including a temporary or permanent injunction.

4 (B) Any order issued pursuant to division (A) above may include a
5 suspension or revocation of any permit, or portion thereof, issued by the
6 DirectorMayer. Any penalty assessed in the order shall not exceed \$15,000 per
7 day of noncompliance for each violation.

8 (C) Any order issued pursuant to division (A) above shall become final
9 unless, no later than 30 days after the order is served, the person named therein
10 submits a written request to the Director for a public hearing. Upon such
11 request, the Director shall promptly conduct a public hearing. The Director shall
12 appoint an independent hearing officer to preside over the public hearing. The
13 hearing officer shall make and preserve a complete record of the proceedings
14 and forward the hearing officer's recommendation based thereon to the
15 Director, who shall make the final decision.

16 (D) The Board may adopt a field citation program through regulations
17 establishing appropriate minor violations for which field citations assessing
18 civil penalties not to exceed \$1,000 per day of violation may be issued by
19 officers or employees of the Department as designated by the DirectorMayer.
20 The program will be implemented by the Department.

21 (E) Any person to whom a field citation is issued pursuant to division (D)
22 above may, within a reasonable time as prescribed by regulation by the Board,
23 elect to pay the penalty assessment or to request a hearing by the issuing
24 agency on the field citation. If a request for hearing is not made within the time
25 specified in the regulation, the penalty assessment in the field citation shall be
26 final.

27 (F) Payment of a civil penalty required by a field citation issued pursuant
28 to division (D) above shall not be a defense to further enforcement by the
29 Department to correct a violation or to assess the maximum statutory penalty
30 pursuant to other authorities in the Air Quality Control Act or §§ 9-5-1-1 et seq.
31 if the violation continues.

32 (G) In determining the amount of any penalty to be assessed pursuant to
33 this section, the Director or the individual issuing a field citation shall take into

1 account the seriousness of the violation, any good-faith efforts to comply with
2 the applicable requirements and other relevant factors.

3 (H) In connection with any proceeding under this section, the Director
4 may issue subpoenas for the attendance and testimony of witnesses and the
5 production of relevant papers, books and documents and may adopt rules for
6 discovery procedures.

7 (I) Penalties collected pursuant to an administrative order or a field
8 citation shall be deposited in the city or the county general fund, as applicable.
9 § 9-5-1-99 PENALTY.

10 (A) Civil Penalty. Any person who violates any provision of the Air Quality
11 Control Act, §§9-5-1-1 et seq., any regulation of the Board or any permit
12 condition or emergency order adopted or issued pursuant to the Air Quality
13 Control Act or §§ 9-5-1-1 et seq. may be assessed a civil penalty not to exceed
14 \$15,000 for each day during any portion of which a violation occurs.

15 (B) Criminal Penalties.

16 (1) Any person who knowingly commits any violation of §§9-5-1-1 et seq.
17 or a regulation of the Board which is not described as a felony in Section 74-2-
18 14.C or 74-2-14.D NMSA 1978 is guilty of a misdemeanor and shall be sentenced
19 in accordance with the provisions of Section 31-19-1 NMSA 1978.

20 (2) Any person who knowingly makes any false statement, representation
21 or certification in any application, record, report, plan or other document filed
22 or required to be maintained under the Air Quality Control Act or who falsifies,
23 tampers with or knowingly renders inaccurate any monitoring device or method
24 to be maintained under the Air Quality Control Act or §§ 9-5-1-1 et seq. or
25 regulation adopted pursuant thereto is guilty of a petty misdemeanor and shall,
26 upon conviction, be punished by a fine of not more than \$10,000, per day for
27 each violation, or by imprisonment for not more than six months, or by both.”

28 Section 3. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
29 clause, word, or phrase of this ordinance is for any reason held to be invalid or
30 unenforceable by any court of competent jurisdiction, such decision shall not
31 affect the validity of the remaining provisions of this ordinance. The Council
32 hereby declares that it would have passed this ordinance and each section,
33 paragraph, sentence, clause, word, or phrase thereof irrespective of any

1 provision being declared unconstitutional or otherwise invalid.

2 Section 4. COMPILATION. This ordinance shall be incorporated in and made
3 part of the Revised Ordinances of Albuquerque, New Mexico 1994.

4 Section 5. EFFECTIVE DATE. This ordinance shall take effect December 3,
5 2023.
