6 WHEREAS, the Department of Solid Waste submitted a grant application to  
7 the New Mexico Environment Department through the Recycling and Illegal  
8 Dumping Fund (RAID). The grant application approved and awarded to the City  
9 of Albuquerque in the amount of \$7,445.06; and


10 WHEREAS, estimated IDOH in the amount of \$655.17 is required to support  
11 the grant; and the RAID grant does not allow for the reimbursement of indirect  
12 costs; and

13 WHEREAS, the grant will assist Solid Waste in completing the One  
14 Albuquerque Elementary Recycling Education Program in educating students  
15 to adopt sustainable recycling habits and become environmental stewards;

17 WHEREAS, the grant will pay for educational and informational materials  
18 and resources as well as guest speakers and presenters.

21 Section 1: That Council hereby approves and authorizes the appropriation  
22 from the New Mexico Environment Department, Recycling and Illegal Dumping  
23 Fund (RAID) grant in the amount of \$7,445.06, and indirect cost of \$655.17 from  
24 the Central Services Division of the Solid Waste Operating Fund, are hereby  
25 appropriated to the Solid Waste Department in the Operating Grants Fund  
26 (265) for Fiscal Year 2025.







# **Cover Analysis**

## **1. What is it?**
