| 3 | § 9-2-4-4 SALE OR GIFT OF AN ANIMAL. |
| 4 | (A) Public Property. No Person shall display, sell, deliver, offer for sale, |
| 5 | barter, auction, give away, or otherwise dispose of an Animal upon a street, |
| 6 | sidewalk, public park, public right-of-way or other public property. Adoption |
| 7 | events approved by the Mayor's designee, or any adoption events held by a |
| 8 | Rescue Group or Rescue individual are exempt. |
| 9 | [(1) If a Person is found to be in violation of this section, the Mayor's |
| 10 | designee shall immediately Seize and Impound any Animals found in the |
| 11 | Person's public possession. |
| 12 | (2) Consistent with the Intake Process and other practices related to lost |
| 13 | and found Companion Animals, the Mayor's designee shall immediately Alter, |
| 14 | Microchip, and otherwise ensure all standards established by this article and |

| 21 | § 9-2-3-7 COMPANION ANIMAL LITTER PERMIT. |
| 22 | (H) The following Care and Disposition requirements regarding Litter |
| 23 | Companion Animals are in effect whether or not the Owner of the Litter |
| 24 | possesses a Litter Permit: |
| 25 | (8) Puppies and kittens can only be sold, given as a gift or other transfer or |
| 26 | conveyance from the location listed on the Litter Permit. Puppies or kittens |
| 27 | being sold on public property or commercial property even with the Owner's |
| 28 | permission are in violation of this article and the puppies and kittens [and any |

permission are in violation of this article and the puppies and kittens [and any other Animals in the Person's public possession shall [may] be seized [and Impounded pursuant to Section 9-2-4-4(A) of this article].

SECTION 2. SEVERABILITY. If any section, paragraph, sentence, clause, word or phrase of this Ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not
