R-23-180 SPONSORED BY: Tammy Fiebelkorn, by request 1 RESOLUTION 2 APPROVING AND AUTHORIZING THE ACCEPTANCE OF GRANT AWARDS FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) AND 3 PROVIDING FOR AN APPROPRIATION TO THE DEPARTMENT OF FINANCE 4 AND ADMINISTRATION FOR FISCAL YEARS 2024, 2025 and 2026. 5 WHEREAS, one of the goals of the City of Albuquerque as an immigrant 6 friendly city is to improve the lives of immigrants, refugees, and asylees living 7 8 in and traveling through Albuquerque; and WHEREAS, Article VIII of the City Charter states that, "The Council shall 9 preserve, protect and promote human rights and human dignity.... and shall 10 - Deletion prohibit discrimination on the basis of race, color, religion, sex, national origin 11 Bracketed/Underscored Material] - New 12 or ancestry, age or physical handicap"; and WHEREAS, the Albuquerque City Council re-affirmed its commitment to 13 Bracketed/Strikethrough Material 14 immigrant integration and inclusion exemplified in R-00-151 by passing M-17-4 which states "the Council welcomes and encourages immigrants to live, work, 15 and study in Albuquerque and to participate in community affairs, and 16 recognizes immigrants for their important contributions to our culture and 17 18 economy"; and 19 WHEREAS, the Federal Emergency Management Agency has made available to Albuquerque the shelter and services program to provide shelter, 20 21 food, transportation, acute medical care, personal hygiene supplies, and labor 22 to provide these services; and 23 WHEREAS, in order to meet the emergent need, the City was awarded Federal Funding on September 28, 2023 EMW-2023-SP-05176; and 24 25 WHEREAS, grant funds in the approximate amount of \$757,694 will be used to assist asylees in the Albuquerque area; and 26
