**APPROVING AND AUTHORIZING THE FILING OF THE ATTACHED GRANT APPLICATION FOR AN E911 GRANT PROGRAM FROM THE NEW MEXICO DEPARTMENT OF FINANCE AND ADMINISTRATION, LOCAL GOVERNMENT DIVISION AND PROVIDING FOR AN APPROPRIATION TO THE CITY OF ALBUQUERQUE, POLICE DEPARTMENT.**




