1 RESOLUTION  
2 APPROVING THE ATTACHED GRANT APPLICATION FOR THE FY2018  
3 HAZARDOUS MATERIALS PUBLIC SECTOR TRAINING AND PLANNING  
4 GRANT WITH THE NEW MEXICO DEPARTMENT OF HOMELAND SECURITY  
5 AND PROVIDING FOR AN APPROPRIATION TO ALBUQUERQUE FIRE  
6 RESCUE IN FISCAL YEAR 2019.

7 WHEREAS, the New Mexico Department of Homeland Security and  
8 Emergency Management is distributing funds to eligible entities; and

9 WHEREAS, Albuquerque Fire Rescue will use this grant to attend the IAFC  
10 International Hazmat Conference; and

11 WHEREAS, grant funds in the amount of \$2,040 for this purpose are  
12 available to the City of Albuquerque from the FY18 Hazardous Materials Public  
13 Sector Training and Planning Grant; and

14 WHEREAS, the City of Albuquerque desires to accept these funds, which  
15 require a \$510 cash match and is available in the General Fund.

16 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF  
17 ALBUQUERQUE:

18 Section 1. That the application with the New Mexico Department of  
19 Homeland Security and Emergency Management in the amount of \$2,040 in  
20 Federal Funds is hereby approved, and its acceptance and filing with the  
21 appropriate official or office is and in all respects approved.

22 Section 2. That funds in the amount of \$2,550, consisting of \$2,040 in  
23 federal monies from the New Mexico Department of Homeland Security and  
24 Emergency Management and \$510 cash match from the General Fund Transfer  
25 to Operating Grants Fund (265) program in the General Fund (110), are hereby




