[By July 28, 2011, all owners of buildings that fall within the scope of these requirements shall have fire sprinkler plans submitted to the Fire Marshal's Office Plans Review Section for review and approval. By July 28, 2012, every building falling within the scope of these requirements shall be in compliance, unless such building undergoes a repair, alteration or remodel of more than 50 percent of the aggregate square footage of the building or submits for an increase in the posted occupant load prior to the compliance date.]

24 [Buildings existing as of the date of the City of Albuqurque's adoption of 25 the 2003 International Fire Code, April 29, 2005, shall not be subject to Section

903.2.1.2 except as provided for in Section 102.1 of the 2003 International Fire Code.]

SECTION 2. SEVERABILITY CLAUSE. If any section, paragraph, sentence, clause, word or phrase of this ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this ordinance. The Council hereby declares that it would have passed this ordinance and each section, paragraph, sentence, clause, word or phrase thereof irrespective of any provision being declared unconstitutional or otherwise invalid.

SECTION 3. EFFECTIVE DATE. This ordinance shall take effect five days after publication by title and general summary.
