1 **ORDINANCE**

2 **AMENDING CHAPTER 2, ARTICLE 12, SECTION 4 ROA 1994 TO EXTEND THE**
3 **DEADLINE FOR THE CITY COUNCIL TO PROVIDE POLICY GUIDELINES FOR**
4 **THE CAPITAL IMPROVEMENTS PROGRAM DURING EVEN NUMBERED**
5 **YEARS.**

6 **BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF**
7 **ALBUQUERQUE:**

8 **SECTION 1. AMENDING SECTION 2-12-14 TO EXTEND THE DEADLINE FOR**
9 **THE CITY COUNCIL TO PROVIDE POLICY GUIDELINES FOR THE CAPITAL**
10 **IMPROVEMENTS PROGRAM DURING EVEN NUMBERED YEARS.**

11 **“§ 2-12-4 CITY COUNCIL PARTICIPATION.**

12 **(A) Prior to the first City Council meeting in November of odd**
13 **numbered years, the Mayor shall submit a resolution to the City Council with**
14 **proposed policy guidelines for the upcoming Capital Improvements Program.**
15 **The City Council shall adopt the resolution as submitted, or as amended by**
16 **the City Council, on or before January 31 of even numbered years. Should the**
17 **Council fail to provide policy guidelines on or before January 31, the Mayor's**
18 **guidelines shall direct the development of the Capital Improvements Program.**

19 **(B) During the preparation of the proposed Capital Improvements**
20 **Program by the Mayor, he shall furnish any requested information on**
21 **departmental requests to the staff of the City Council and shall cooperate with**
22 **City Council staff so that it may monitor the program development process**
23 **and prepare preliminary analyses and other information for the City Council.**

24 **(C) A representative of the Council shall be allowed to attend the**
25 **meetings during which the Mayor and CAO formally review the program**
26 **recommendations by the CIP Review Group or other similar body.”**

1 **SECTION 2. SEVERABILITY CLAUSE.** If any section, paragraph, sentence,
2 clause, word or phrase of this ordinance is for any reason held to be invalid or
3 unenforceable by any court of competent jurisdiction, such decision shall not
4 affect the validity of the remaining provisions of this ordinance. The Council
5 hereby declares that it would have passed this ordinance and each section,
6 paragraph, sentence, clause, word or phrase thereof irrespective of any
7 provision being declared unconstitutional or otherwise invalid.

8 **SECTION 3. COMPILATION.** The ordinance amendment prescribed by
9 **SECTION 1** shall amend, be incorporated in and made part of the Revised
10 Ordinances of Albuquerque, New Mexico, 1994.

11 **SECTION 4. EFFECTIVE DATE.** This ordinance shall take effect five days
12 after publication by title and general summary.
