1 RESOLUTION

2 APPROVING THE ATTACHED GRANT APPLICATION FOR THE FY2019 FIRE  
3 PROTECTION GRANT WITH THE NEW MEXICO STATE FIRE MARSHAL'S  
4 OFFICE AND PROVIDING FOR AN APPROPRIATION TO THE ALBUQUERQUE  
5 FIRE RESCUE IN FISCAL YEAR 2019.

6 WHEREAS, the New Mexico State Fire Marshal's Office is distributing funds  
7 to eligible entities; and

8 WHEREAS, the Albuquerque Fire Rescue will use this grant to purchase  
9 fire apparatus equipment to provide better cancer prevention measures and to  
10 help create a successful flash hood exchange program; and

11 WHEREAS, grant funds in the amount of \$89,825 for this purpose are  
12 available to the City of Albuquerque from the FY2019 Fire Protection grant;  
13 and

14 WHEREAS, the City of Albuquerque desires to accept these funds, which  
15 require a \$9,980 cash match and is available in the General Fund.


16 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF  
17 ALBUQUERQUE:

18 Section 1. That the application with the New Mexico State Fire Marshal's  
19 Office for the amount of \$89,825 in State Funds is hereby approved, and its  
20 acceptance and filing with the appropriate official or office is and in all  
21 respects approved.

22 Section 2. That funds in the amount of \$99,805, consisting of \$89,825 in  
23 State monies from the New Mexico State Fire Marshal's Office and a \$9,980  
24 cash match from Transfer to Operating Grants Fund (265) program in the  
25 General Fund (110), are hereby appropriated to the Albuquerque Fire Rescue  
26 in the Operating Grant Fund 265 for Fiscal Year 2019.


