1 RESOLUTION

2 AMENDING R-25-169 TO EXTEND THE DEADLINE FOR IMPLEMENTATION OF
3 A WORKING WEB-BASED TOOL FOR USE WHEN SUBMITTING A
4 COMPREHENSIVE PLAN ANALYSIS FOR RELEVANT LEGISLATIVE ITEMS.

5 WHEREAS, R-25-169, Enactment No. R-2025-057, adopted by the
6 Albuquerque City Council on September 3, 2025, and enacted on September
7 17, 2025, requires a Comprehensive Plan Analysis for certain legislative items;
8 and

9 WHEREAS, R-25-169, Enactment No. R-2025-057 directs the Administration
10 to work with Council Planning staff to develop a web-based tool that allows for
11 efficient generation of Comprehensive Plan Analyses and for storage of all
12 CPA data for the purpose of updating Table 14-3: Policy Implementation
13 Action Matrix for the 5 and 10 year Comprehensive Plan updates; and

14 WHEREAS, R-25-169, Enactment No. R-2025-057 directs that the web-based
15 tool be working and available for City staff to use within 90 days following
16 adoption; and

17 WHEREAS, the Planning Department, the Department of Technology &
18 Innovation, and Council Planning staff have worked since September to
19 establish needs and specifications for the required tool; and

20 WHEREAS, additional time is needed to develop an optimal and fully
21 functioning web-based tool for the purposes established by R-25-169,
22 Enactment No. R-2025-057.

23 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
24 ALBUQUERQUE:

25 SECTION 1. The original 90-day deadline contained in Section 3 of R-25-
26 169, Enactment No. R-2025-057 is hereby extended by 90 days. The

1 Administration and Council Planning Staff shall have a working web-based
2 tool for City staff to use when submitting CPAs for relevant legislative items
3 as required by R-25-169 within 90 days from the effective date of this
4 Resolution.

5 SECTION 2. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
6 clause, word or phrase of this Resolution is for any reason held to be invalid
7 or unenforceable by any court of competent jurisdiction, such decision shall
8 not affect the validity of the remaining provisions of this Resolution. The
9 Council hereby declares that it would have passed this Resolution and each
10 section, paragraph, sentence, clause, word or phrase thereof irrespective of
11 any provisions being declared unconstitutional or otherwise invalid.

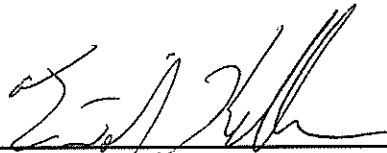
