1 RESOLUTION

2 APPROVING AND AUTHORIZING THE ACCEPTANCE OF 2020 GO BONDS
3 FROM THE STATE OF NEW MEXICO FOR PUBLIC LIBRARIES
4 ALBUQUERQUE/BERNALILLO COUNTY LIBRARY SYSTEM, AND PROVIDING
5 FOR AN APPROPRIATION TO THE DEPARTMENT OF ARTS & CULTURE IN
6 FISCAL YEAR 2024.

7 WHEREAS, the City of Albuquerque has as one of its goals to promote
8 the educational and cultural development of the widest possible spectrum of
9 individuals in the community; and

10 WHEREAS, the 2020 State GO Bonds for Public Libraries
11 Albuquerque/Bernalillo County Library System, if accepted, will enable the
12 Albuquerque Public Library to fulfill this goal through the New Mexico State
13 Library to provide supplementary popular reading materials for Albuquerque
14 citizens; and

15 WHEREAS, funds for this purpose, in the amount of \$865,137.80 have
16 been appropriated by the New Mexico Legislature through the New Mexico
17 State Library; and

18 WHEREAS, the City of Albuquerque is eligible to receive these funds.
19 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
20 ALBUQUERQUE:

21 SECTION 1. That the attached Purchase Order in the amount of
22 \$865,137.80 is hereby approved, and its submission and filing with the
23 appropriate official or office of the New Mexico State Library is in all respects
24 approved.

25 SECTION 2. That upon approval, funds in the amount of \$865,137.80
26 consisting of \$865,137.80 from the State of New Mexico are hereby




