1 Convenience center commercial:

2 \$5.00 per load (plus tax) [for businesses located within Albuquerque city
3 limits

4 \$12.00 per load (plus tax) for businesses located outside of Albuquerque
5 city limits]

6 Convenience center residential:

7 \$5.00 per load (plus tax) per each individual [for individuals who reside
8 within Albuquerque city limits

9 \$12.00 per load (plus tax) per each individual for individuals who reside
10 outside of Albuquerque city limits]

11 Residential uncovered and/or unsecured load:

12 An additional \$5.54 per vehicle [for individuals who reside within
13 Albuquerque city limits].

14 [An additional \$12.00 per vehicle for individuals who reside outside of
15 Albuquerque city limits.]

16 Commercial uncovered and/or unsecured load:

17 An additional \$5.54 per vehicle [for businesses located within Albuquerque
18 city limits].

19 [An additional \$12.00 per vehicle for business located outside of
20 Albuquerque city limits.]

21 [SECTION 2. ROA 1994 § 9-10-1-11 “COLLECTION FEES” subsection (J)(2)
22 is amended as follows:

23 (J) Use of City Municipal Landfill and Convenience Centers.

24 ...

25 (2) City Convenience Centers.

26 (a) Any residential producer of refuse may dispose of same at any
27 City Convenience Center for a fee set forth in the Collections and Disposal
28 Rates Appendix per each individual load plus applicable gross receipts and
29 local option taxes or \$1 per each individual load plus applicable gross receipts
30 and local option taxes. Any uncovered and/or unsecured load will be charged
31 an additional fee set forth in the Collections and Disposal Rates Appendix,
32 which includes the applicable effective dates, per individual load plus

applicable gross receipts and local option taxes. A load is equivalent to 64 cubic feet (4'X8'X2').

(b) Any business or institution may dispose of commercial refuse, except unauthorized waste, infectious wastes or hazardous waste, at any City Convenience Center for a fee set forth in the Collections and Disposal Rates Appendix, which includes the applicable effective dates, per each individual load plus applicable gross receipts and local option taxes. Any uncovered and/or unsecured load will be charged an additional fee as set forth in the Collections and Disposal Rates Appendix per individual load plus applicable gross receipts and local option taxes. A load is equivalent to 64 cubic feet (4'X8'X2').

[(c) Persons seeking disposal rates applicable to residents or businesses located within Albuquerque city limits shall provide verification of residency in the form of a utility bill dated within the preceding 60 days, or a valid government-issued identification card, showing a residential or business address within Albuquerque city limits. Persons who fail to provide such documentation shall be charged the applicable rate for persons or businesses located outside Albuquerque city limits.]

~~[(e)]~~[(d)] Any vehicle transporting material to any City Convenience Center is limited to a rated capacity of under two tons.

~~[(d)]~~[(e)] Salvaging and scavenging is prohibited at the city landfill, transfer stations, and convenience centers at all times without the written permission of the Mayor.]

SECTION ~~[2]~~[3]. SEVERABILITY. If any section, paragraph, sentence, clause, word, or phrase of this Ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance. The Council hereby declares that it would have passed this Ordinance and each section, paragraph, sentence, clause, word, or phrase thereof irrespective of any provision being declared unconstitutional or otherwise invalid.

SECTION ~~[3]~~[4]. COMPILATION. SECTION 1 of this Ordinance amends, is incorporated in, and is to be compiled in ROA 1994 § 9-10-1.

SECTION ~~[4]~~[5]. EFFECTIVE DATE. This Ordinance takes effect 5 days after publication by title and general summary.
