RESOLUTION

**ESTABLISHING A COMMUNITY BASED PROCESS TO FIND SOLUTIONS
FOR THE *LA JORNADA* INSTALLATION.**

WHEREAS, on June 16, 2020 part of the *La Jornada* installation, was temporarily removed as an emergency act of public safety with the written consent of the artist Reynaldo “Sonny” Rivera; and

WHEREAS, *La Jornada* by Rivera and Betty Sabo depicts the expedition of Spanish settlers and soldiers to New Mexico, and *Numbe Whageh* by Nora Naranjo Morse of Santa Clara Pueblo is a contemplative earthwork that honors a place of solace and reflection commissioned as a response to the *La Jornada* in 1998 (completed in 2004); and

WHEREAS, *La Jornada* is part of the City of Albuquerque’s Public Art collection and sits on the grounds of the City’s Albuquerque Museum, a public institution dedicated to sharing “the stories of our rich heritage and many cultures”; and

WHEREAS, the City of Albuquerque’s Public Art collection is guided by the Albuquerque Arts Board; and

WHEREAS, in June 2020, the Cultural Services Department established the Race, History & Healing Project to initiate and support community-centered dialogue in response to community concern about the *La Jornada* installation; and

WHEREAS, the Race, History & Healing Project begins with an open invitation to all community voices and a steadfast commitment to collective solution building through facilitated meetings, public input, and discussion designed to engage as many community members as possible; and


