22	SECTION 1. A 15-member City Charter Review Task Force shall be	
23	established to review the City Charter and evaluate provisions that should be	
24	amended, added, or deleted.	
25	(A) The Task Force shall be made up of the following members:	
26	(1) One member selected by each City Councilor;	

1	(2) One at-large member selected by the City Council who shall
2	chair the Task Force;
3	(3) Five members appointed by the Mayor.
4	(B) The Task Force shall hold its first meeting no later than August 1,
5	2024, and shall provide its recommendations for City Charter amendments in a
6	report to the City Council and the Mayor on or before February 1, 2025. Upon
7	presentation of its recommendations, the Task Force shall be discharged.
8	(C) The charge of the Task Force shall be to examine the City Charter for
9	the purpose of recommending amendments. The charge includes, but is not
10	limited to, examination of the following:
11	(1) P-24-1 and R-24-47 as introduced by the City Council;
12	(2) P-24-2 and R-24-48 as introduced by the City Council;
13	(3) P-24-3 and R-24-49 as introduced by the City Council; and
14	(4) P-24-4 and R-24-50 as introduced by the City Council.
15	(D) All meetings of the Task Force or its committees shall be open
16	meetings, and the Task Force shall hold at least one public hearing during
_ 17	which input from the public will be sought.
