1 RESOLUTION
2 APPROVING AND AUTHORIZING NEW MEXICO DEPARTMENT OF
3 TRANSPORTATION FUNDS FOR THE PURPOSE OF CONDUCTING A 2010
4 TRAFFIC SAFETY EDUCATION AND ENFORCEMENT PROJECT AND
5 PROVIDING FOR AN APPROPRIATION TO THE CITY OF ALBUQUERQUE,
6 POLICE DEPARTMENT.

7 WHEREAS, the City of Albuquerque has as one of its goals to enhance
8 local law enforcement efforts thereby providing for the public safety and
9 welfare; and

10 WHEREAS, the City of Albuquerque is committed to improving the safety
11 and education of its officers; and

12 WHEREAS, grant funds in the amount of \$48,026 will be used to purchase
13 safety equipment and training to improve the safety and quality of its traffic
14 services; and

15 WHEREAS, the City of Albuquerque is desirous of accepting these funds
16 for which indirect costs of \$1,009 are required to support this grant and are
17 available in the FY/11 Transfer to Operating Grants Fund Program in the
18 General Fund.

19 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
20 ALBUQUERQUE:

21 Section 1. That the attached grant application is hereby made a part of this
22 resolution, is hereby approved and its submission and filing with the
23 appropriate official or office of the New Mexico Department of Transportation
24 is in all respects approved.

25 Section 2. That upon award, funds in the amount of \$48,026 from the New
26 Mexico Department of Transportation and indirect costs of \$1,009 from the


