12 ALBUQUERQUE:

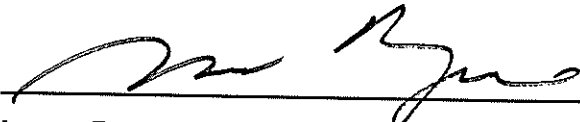

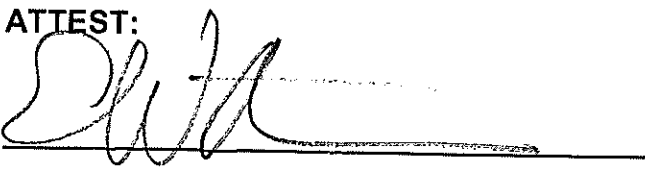
