Pursuant to the PID Act and City Ordinance Enactment No. 0-2003-12, Council Bill No. FS 0-03-84, the Council enacted the Formation Resolution for the Montecito Estates Public Improvement District (Council Bill No. R-07-246), in which the Council approved the formation of the District for the principle purpose of financing certain public infrastructure improvements.

Pursuant the section 6 of the Formation Resolution, Section 5-11-9(A), NMSA 1978, and Section 1 of Council Bill No. R-09-253, the following five (5) individuals were most recently named as the members and, as applicable, officers, of the District Board of Directors: Michael Riordan (6-year term), Michael Cadigan (6-year term), Christopher Daniel (6-year term and District Clerk), Jacques Blair (4-year term), and Greg Stricklin (4-year term and District Treasurer).

Of the appointed members of the District Board, Michael Cadigan and Greg Stricklin have resigned and the 4-year term of Jacques Blair has now expired. The following person has agreed to serve as a replacement member of the District Board: Jacques Blair (replacing Michael Cadigan). Christopher Daniel has also agreed to act as District Treasurer. Messrs. Blair and Daniel would hold their respective office for the remainder of the unexpired six-year term until his successor is appointed or elected.
