Cover Analysis

1. What is it?

A Resolution authorizing submission of an application to create an Alternate Site Framework Foreign Trade Zone.

2. What will this piece of legislation do?

The Resolution authorizes the Aviation Director to submit an Application to the Federal Foreign Trade Zones Board to reorganize the City's General Purpose Foreign-Trade Zone No. 110 under the Alternative Site Framework, and to execute agreements with prospective companies to be in the Zone.

3. Why is the project needed?

The current zone configuration of one site is very limited. The proposed Alternative Site Framework will expand the service area to Bernalillo, Sandoval, Santa Fe, Torrance, Socorro, and Valencia Counties. This expansion will allow the City of Albuquerque to attract and accommodate economic development opportunities by offering foreign-trade zone status to companies desiring to utilize it, will encourage international business activities, and will increase employment opportunities and investment in the Albuquerque area.

4. How much will it cost and what is the funding source?

The Aviation Department will spend between \$1,500 and \$2,000 to execute the application.

5. Is there a revenue source associated with the project? If so, what level of income is projected?

Foreign Trade Zone users will pay an annual fee to the Aviation Department which is currently set at \$6,000.
