1 SECTION 4. 2013 ELECTION. That the areas established by Attachment A
2 as the nine Council Districts are for the purposes of Municipal Elections
3 starting with the election of October 8, 2013 and all subsequent Municipal
4 Elections until the next redistricting; for all other purposes, the effective date
5 for the Council Districts created by Attachment A is the effective date of this
6 ordinance. Each of the current incumbents in the nine Council Districts will
7 remain in office until the expiration of the term to which he or she was elected.

8 SECTION 5. COMMITTEE REPORT. For the purpose of maintaining
9 records of the activities and recommendations of the Redistricting Committee,
10 the attached report of the Redistricting Committee (Attachment B) is hereby
11 received and incorporated herein as if set out in full.

12 SECTION 6. PRECINCTS. For the purpose of identifying the precincts in
13 each Council District, a map identifying Council Districts by precinct is
14 attached as Attachment C and is incorporated herein as if set out in full and is
15 hereby adopted as to precincts.

16 SECTION 7. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
17 clause, word or phrase of this ordinance is for any reason held to be invalid or
18 unenforceable by any court of competent jurisdiction, such decision shall not
19 affect the validity of the remaining provisions of this ordinance. The Council
20 hereby declares that it would have passed this ordinance and each section,
21 paragraph, sentence, clause, word, or phrase thereof irrespective of any
22 provision being declared unconstitutional or otherwise invalid.

23 SECTION 8. EFFECTIVE DATE. This ordinance shall take effect five days
24 after publication by title and general summary but without the ordinance's
25 attachments.


