

SUBJECT: Resolution approving and authorizing the FY23 - FY24 American Rescue Plan Air

For your consideration, please find the attached resolution allowing the Environmental Health Department Air Quality Program to apply funding already received to the American Rescue Plan Air Monitoring Grant for Fiscal Year 2023-2024. This Grant was applied for April 4, 2022, and the funds were received July 1, 2022. This Grant Award letter was received before submittal because of the uncertainty of the final Grant Award. No Grant funds have been allocated or spent. The program supports ongoing air quality monitoring of fine particulate matter and distributing information to our citizens and industries regarding air quality and pollution.

The attached grant application is for 100% federal funding from the U.S. Environmental Protection Agency of \$115,000 from July 1, 2023, through June 30, 2024. City matching funds are not required.

The attached resolution is submitted for consideration and action by the Council.

Cover Analysis

1. What is it?

The purpose of this American Rescue Plan funded cooperative agreement is to advance enhanced monitoring of Particulate Matter 2.5 (PM2.5) or other National Ambient Air Quality Standards (NAAQS) pollutants in and near communities with environmental justice concerns that face disproportionate exposure to these pollutants and health risks which are also associated with increased vulnerability to COVID-19. As a recipient of the EPA grant, the City of Albuquerque will Review and compare EPA proposed equipment for purchase and determine if any adjustments need to be made on enhancements at various air monitoring sites based on current needs.

Complete automation of PM2.5 monitors will provide all communities with fine particulate data of the same quality and allow them to compare continuous data streams in nearby areas. Operation of PM2.5 or other NAAQS pollutants air monitoring following all EPA requirements leading to collection of quality assured ambient air quality data to help ensure that more Americans are living and working in areas that meet high air quality standards. These activities' Direct beneficiaries are community residents with a decreased risk of adverse health effects, including cancer and neurological effects.

2. What will this piece of legislation do?

Allow the Mayor to accept federal funding from the US EPA for the operation of Albuquerque's Ambient Air Monitoring Program and administer the appropriation for the American Rescue Plan Grant for Federal FY2023 to FY2024.

3. Why is the project needed?

These funds will primarily be used to replace existing filter-based monitors or otherwise enhance existing monitors in and near those communities to provide 24/7, real-time reporting of air quality concentrations. Complete automation of PM2.5 monitors will provide all communities with fine particulate data of the same quality and allow them to compare continuous data streams in nearby areas. The funds may address other considerations in and near communities with environmental justice concerns, including upgrading other NAAQS pollutant monitoring sites, upgrading specific NAAQS gas monitors and/or equipment not meeting performance or completeness goals, and other possible PM monitoring investments.

4. How much will it cost, and what is the funding source?

The award is \$115,000 from July 1, 2023, through June 30, 2024. There are no matching funds required for this grant. The US EPA is the Grantor.

5. What will happen if the project is not approved?

Funds would be returned to the Environmental Protection Agency, and no equipment upgrades would be completed.

Project Objectives and Alignment with EPA Strategic Plan:

The primary objective of this project is to enhance monitoring of PM2.5 or other National Ambient Air Quality Standard (NAAQS) pollutants in and near communities with environmental justice concerns who face disproportionate exposure to these pollutants and health risks which are also associated with increased vulnerability to COVID-19.

These funds will primarily be used to replace existing filter-based monitors or otherwise enhance existing monitors in and near those communities to provide 24/7, real-time reporting of air quality concentrations. Full automation of PM2.5 monitors will provide all communities fine particulate data of the same quality and allow them to compare continuous data streams in nearby areas. The funds may be used to address other considerations in and near communities with environmental justice concerns including upgrading other NAAQS pollutant monitoring sites, upgrading certain NAAQS gas monitors and/or equipment not meeting performance or completeness goals, and other possible PM monitoring investments.

This project supports EPA's Strategic Plan Goal 4 Ensure Clean and Healthy Air for All Communities (Protect human health and the environment from the harmful effects of air pollution) and Objective 4.1 Improve Air Quality and Reduce Localized Pollution and Health Impacts (Reduce air pollution on local, regional, and national scales to achieve healthy air quality for people and the environment). By enhancing air monitoring, this will assist in achieving and maintaining health-based air pollution standards to reduce the direct emission of particulate matter and other criteria air pollution from stationary and mobile sources that are protective of human health. The environmental outcome will be reduced incidences of respiratory illnesses including asthma and lung cancer and improved visibility in and near these communities.


