Instructions for Public Participation for the January 23, 2023 Finance and Government Operations Committee meeting

- **Virtual, Live Comments:** To provide real time verbal public comment over Zoom, participants must sign up for public comment by 4:00 p.m. on the day of the meeting. - **Note:** Participants must sign up for public comment with the Zoom username or phone number that they will be entering the Zoom meeting with so that they can be identified when accessing the meeting. - Public comment will be limited to 2 minutes or less, depending on the number of speakers signed up. Your time will start when you begin speaking and you will be informed when your time has concluded, at which point your microphone will be muted and your camera will be turned off.
