1 RESOLUTION
2 APPROVING THE APPOINTMENT OF A DIRECTOR TO FILL THE VACANCY ON
3 THE GOVERNING BODY OF THE INSPIRATION PUBLIC IMPROVEMENT
4 DISTRICT, CAUSED BY THE RESIGNATION OF A DIRECTOR, PURSUANT TO
5 THE PUBLIC IMPROVEMENT DISTRICT ACT, NMSA 1978 § § 5-11-1 TO -27
6 (2019, AS AMENDED) AND CITY ENACTMENT NO. O-2003-12, CITY
7 ENACTMENT NO R-2007-150, AND REPEALING ALL ACTIONS INCONSISTENT
8 WITH THIS RESOLUTION.

9 Capitalized terms used herein shall have the meanings assigned in City
10 Enactment No. R-2020-038, adopted on April 20, 2020, except as otherwise
11 defined in this Resolution, or unless the context clearly requires otherwise.

12 WHEREAS, pursuant to Section 5-11-9(A) of the Act, the Council is
13 empowered to appoint directors to fill vacancies on the governing body of the
14 District because of death, resignation or inability of a director to discharge the
15 duties of director, which appointee shall hold office for the remainder of the
16 unexpired term until a successor is appointed or elected; and

17 WHEREAS, Stephanie M. Yara has resigned from the District's governing
18 body; and

19 WHEREAS, Elaine T. Romero has volunteered to serve the remainder term
20 of such position.

21 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
22 ALBUQUERQUE:

23 Section 1: Appointments to the Governing Body of the District. Pursuant to
24 Section 5-11-9(A) of the Act, the Council hereby appoints Elaine T. Romero to
25 replace Stephanie M. Yara as a member of the governing body of the District.

1 Elaine T. Romero shall hold office for the remainder of the unexpired term until
2 her successor is appointed or elected.

3 Section 2. Repealer. All ordinances or resolutions, or parts thereof in
4 conflict with the provisions of this Resolution, are hereby repealed to the
5 extent only of such inconsistency. This repealer shall not be construed to
6 revive any ordinance or resolution, or part thereof, heretofore repealed.

7 Section 3. Severability. If any section, paragraph, clause or provision of
8 this Resolution shall for any reason be held to be invalid or unenforceable, the
9 invalidity or unenforceability of such section, paragraph, clause or provision
10 shall in no manner affect any remaining provisions of this Resolution.


