SPONSORED BY: Brook Bassan, by request 1 RESOLUTION 2 APPROVING AND AUTHORIZING THE FILING OF GRANT APPLICATIONS AND 3 THE ACCEPTANCE OF POTENTIAL GRANT AWARDS FOR MULTIPLE CITY 4 DEPARTMENTS FROM ASSOCIATED GRANTOR AGENCIES AND PROVIDING 5 FOR AN APPROPRIATION TO THE CITY OF ALBUQUERQUE. 6 WHEREAS, any application or proposal for a federal or state grant must be 7 submitted to the City Council for review and approval; and 8 WHEREAS, in order to speed the availability of grant funding for critical 9 City programs and to improve the efficiency of the grant application process, 10 the following departments submit for approval a consolidated list of potential 11 awards: Albuquerque Fire Rescue, Albuquerque Police Department, Family 12 and Community Services, Parks and Recreation, Transit, Environmental 13 Health, Office of Equity and Inclusion, Office of Emergency Management, Solid 14 Waste and Senior Affairs; and 15 WHEREAS, potential grant funds in the approximate amount of \$35,238,113 16 will be used to pay for various programs that further the goals of each 17 department and contribute to the wellbeing of the citizens of Albuquerque; 18 and 19 WHEREAS, the City of Albuquerque is desirous of accepting these funds 20 for which funding of \$8,590,514 in City funds will be appropriated and 21 available beginning in the Fiscal Year 2023 for the purpose of meeting grant 22 cash match and indirect overhead requirements. 23 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 24 **ALBUQUERQUE:** 25 Section 1. That the list of estimated grant awards is hereby made a part of

this resolution, is hereby approved and its submission and filing with the

appropriate official or office of the respective granting agency is in all
 respects approved.

Section 2. That upon award, estimated funds from the respective granting agencies listed and the appropriate City cash contributions for the purpose of indirect, FICA or cash match are hereby appropriated to the respective departments in the specified funds beginning in Fiscal Year 2023.

Section 3. That upon award, funds in the amount of \$43,828,627 consisting of \$35,238,113 from granting agencies (which includes \$432,426 for IDOH) and a local match of \$8,590,514 (which includes \$571,024 in IDOH) are hereby appropriated to the departments and funds specified in Section 5 beginning in Fiscal Year 2023, which includes \$5,931,109 from the Fiscal Year 2023 Transfer to Operating Grants Program from the General Fund 110 appropriated to the Operating Grants Fund 265, and \$2,659,405 appropriated from the Transit Capital Implementation Program Fund 305 to Transit Grant Fund 665 and/or the Transfer to Capital Grants program in the Transit Operating Fund 661 to the Capital Grants Fund 665.

Section 4. In the event that departments receive additional grants not listed below or the City cash contributions exceed the appropriated \$5,931,109, departments will be required to submit separate legislation.

Section 5. That the following are potential grant awards with possible City grant match requirements by fund and department:

SUBJECT: FY/23 Grant Omnibus Bill

In order to speed the availability of grant funding for critical programs and increase the efficiency of the City's grant application process, the following departments have submitted a FY/2 Grant Omnibus Bill which lists the potential local, state, and federal grants that each department may receive: Albuquerque Fire Rescue, Albuquerque Police Department, Family and Community Services, Senior Affairs, Environmental Health, Office of Equity and Inclusion, Office of Emergency Management, Solid Waste, Parks and Recreation, and Transit.

Passage of the FY/23 Grant Omnibus Bill will allow these departments to receive grant funds associated with grants for which they intend to apply. If additional grant opportunities are identified after the passage of this FY/23 Grant Omnibus Bill, proposals to apply for those specific grants will be submitted separately.

The amount of \$5,931,109 (which includes \$562,561 in IDOH) will be appropriated and available from the Fiscal Year 2023 Transfer to Operating Grants Program from the General Fund 110 appropriated to the Operating Grants Fund 265, and \$2,659,405 (including \$8,463 in IDOH) will be appropriated from the Transit Capital Implementation Program Fund 305 to Transit Grant Fund 665 and/or the Transfer to Capital Grants program in the Transit Operating Fund 661 to the Capital Grants Fund 665 for the purpose of meeting grant cash match and indirect overhead requirements. In the event that the cash match requirements exceed the appropriated amount, the departments will submit separate legislation.

This Resolution is forwarded to Council for its consideration and action.

2. What will this piece of legislation do?

The legislation authorizes participating departments to accept and utilize grant funds from multiple grantors.

3. Why is this project needed?

The legislation is needed to take advantage of funding opportunities from grants and transfers.

Participating departments will potentially receive \$35238113 from private, local, state, and federal grantors. Funding of \$5,931,109 which includes \$562,561 in IDOH will be appropriated and will be available for the purpose of meeting grant cash match and indirect overhead requirements from the Fiscal Year 2023 Transfer to Operating Grants Program from the General Fund 110. The amount of \$2,659,405 which includes \$2,650,942 in City Match and \$8,463 in City IDOH will be appropriated from monies transferred from the Fiscal Year 2023 Transit Operating Fund 661 and available in Fiscal Year 2023.

FY/23 Citywide Grant Omnibus Resolution Grant Descriptions

Department: Environmental Health

GRANTS WITH POSITIONS

Title: FY23 Air Pollution Control Grant

The U.S. Environmental Protection Agency is distributing funds that support the City of Albuquerque's air quality control programs. These programs provide air pollution control throughout the State of New Mexico, including continuing development and implementation of stationary source regulations; continuing promulgation and update of enhanced mobile source regulations; improvement of emission inventories for modeling simulations; and to operate a monitoring network that collects air data. These activities are to improve and maintain the public's air quality. Grant Period: 10/01/2022 – 09/30/2023. Grant amount is \$2,398,176: City portion is \$1,389,887 and EPA portion is \$1,008,289. Indirect cost is \$298,991. **(Federal)**

GRANTS WITHOUT POSITIONS

Title: Fine Particulate Matter Air Monitoring Grant

Congress has provided the U.S. Environmental Protection Agency with special funding to address special projects designed to enhance public health by reducing air pollution. The grant will provide ongoing ambient monitoring for particulate matter with aerodynamic diameter less than 2.5 microns as required by 40 CFR Part 50 & 58. Grant Period: 04/01/2023 – 03/31/2024. Grant amount is \$169,680: City portion is \$13,284 and EPA portion is \$156,396. Indirect cost is \$13,284. **(Federal)**

Title: DOE Affordable Mobility Project

Department of Energy (DOE), in partnership with Forth to provide cost share for the Affordable Mobility Platform grant. The City of Albuquerque will partner with Forth for this grant to demonstrate and refine a model to provide electric vehicles (EV) and EV charging stations to residents at affordable housing sites. The cost-share commitment will be in-kind support that includes support in recruiting program participation among affordable housing staff and residents, assistance in purchasing and installing two level 2 EV charging stations, and donating parking spaces for car sharing and general public vehicles to charge. Grant Period: 07/01/2022 – 06/30/2023. Grant amount is \$0: City Match is \$100,000. Indirect cost is \$0. **(Federal)**

Department: Police

GRANTS WITH POSITIONS

Title: ONDCP/Region One and NMISC

The grant is funded by the Office of National Drug Control Policy to continue supporting the efforts of the Middle Rio Grande Valley Task Force and the New Mexico Investigative Service Center. The grant will be utilized to fund personnel salaries and benefits, supplies, equipment and contractual services. (Federal Pass-through State)

Title: DNA Act Funds

New Mexico DNA Identification System (NMDIS) has been administered by APD for over 18 years. NMDIS has established successful, statewide database system of DNA samples collected from designated felony offenders. DNA Act funds will be utilized by funding personnel, materials, supplies, and contractual services. **(Federal)**

Title: Violence Against Women Advocate (VAWA) - Competitive

The grant funds will help to expand advocacy to more than one unit within the APD Criminal Investigations Bureau. The project will allow for the establishment of a team of three advocates to provide supportive services and advocacy for victims: a Supervisor to oversee the team; Sex Crimes/FASTT Victim Advocate; and a Cold Case Sex Crimes Victim Advocate. (Federal Pass-through State)

Title: VOCA

The Sex Crimes Unit is responsible for investigating cases resulting from the 4,388 backlogged SAEKs. The SAEKS have roughly an 80% return rate of positive DNA cases that need follow-up. The VOCA funded staff will support victim engagement, case tracking, documenting case resolution and tracking statistical facts. (Federal Pass-through State)

GRANTS WITHOUT POSITIONS

Title: VOCA - Equipment

The Sex Crimes Unit is responsible for investigating cases resulting from the 4,388 backlogged SAEKs. The SAEKS have roughly an 80% return rate of positive DNA cases that need follow-up. The VOCA equipment grant funds the VOCA staff with equipment to help support victim engagement, case tracking, documenting case resolution and tracking statistical facts. (Federal Pass-through State)

Title: Edward Byrne Memorial Justice Assistance Grant

The Edward Byrne Memorial Local Law Enforcement Assistance Grant Program (Byrne Formula Grant Program) will be used for, but not limited to, personnel, supplies, training, equipment, technical assistance, and information systems for more widespread apprehension, prosecution, adjudication, detention, and rehabilitation of offenders who violate such state and local laws. **(Federal)**

Title: JAG/DEAC

The JAG/Region One Narcotics Task Force will support the Southwest Region One in its efforts to disrupt and dismantle drug trafficking. Grant funds will be used for overtime and operational funds to reduce narcotics trafficking sales and related crimes and violence associated with the use of illegal substances. (Federal Pass-through State)

Title: DNA Backlog Reduction Grant (CEBR Formulary)

The goal of NIJ's Forensic DNA Backlog Reduction Program is to reduce forensic DNA sample turnaround time, increase the efficiency of public DNA laboratories, and reduce DNA forensic casework backlogs. These improvements are critical to preventing future DNA backlogs and to helping the criminal justice system use the full potential of DNA technology. APD receives two allotments of funding under the same program; one to purchase equipment and supplies, the other to contract with vendors to reduce DNA backlogs. **(Federal)**

Title: E911 Grant

The purpose of the E911 Grant is to provide E911 network services, consultation, equipment and training. The Local Government Division of the New Mexico Department of Finance and Administration will oversee the grant funds and pay all invoices associated with the E911 Program Grant on behalf of the City of Albuquerque. (State)

Title: Paul Coverdell

The Paul Coverdell Forensic Science Improvement Program was established to assist state and local law enforcement agencies in identifying and implementing the latest technological innovations, maximizing analysis capabilities, and to provide opportunities for physical evidence and information sharing. Grant funds will be used for travel and training to maintain scientist certifications. (Federal Pass-through State)

Title: HIDTA Narcotics

The HIDTA Grant is funded by the Office of National Drug Control Policy to continue supporting the efforts of the Middle Rio Grande Valley Task Force and the New Mexico Investigative Service Center. The grant will be utilized to fund overtime, supplies, and training for the Albuquerque Police Department's Narcotics Division. (Federal Passthrough State)

Title: Pacific State University

APD is collaborating with Pacific State University in a grant-funded research program with long term goals to establish efficacy and effectiveness and widely disseminate an intervention to reduce aggression and excessive use of force, and improve stress reactivity and stress-related mental health among LEOs. APD will use grant funds to purchase equipment and supplies to support the project scope. **(Federal Pass-through)**

Title: BSNF

The grant will be for purchasing drones for Criminalistics. The purpose will be for photographing, mapping, and documenting evidence at outdoor major crime scenes and officer-involved incidents. The ability to use the drone would speed up the time Criminalistics photographed and laser scanned an incident. (Other)

GRANTS FUNDING OVERTIME

Title: Bernalillo County DWI

Bernalillo County passes state funds through to APD to reduce incidences of DWI and influence a decrease in the number of Bernalillo County residents who are injured and/or killed by drunk drivers. APD uses the grant funding to pay officer overtime to conduct DWI sobriety checkpoints; saturation patrols; and other underage drinking law enforcement activities. Grant will also pay for equipment related to DWI / traffic enforcement. (Local)

Title: Buckle UP

The Buckle Up grant allows APD to concentrate its efforts on increasing the use of seat belt restraints for both adults and children. APD uses this funding for officer overtime to support the mission described above. **(State)**

Title: Selective Traffic Enforcement Program (STEP)

The STEP grant is used in areas that have been identified through local analysis as needing targeted intervention due to high rates of crashes and/or DWI, speed, or other traffic-related problems. STEP includes a public awareness component that increases perceptions that consequences will be imposed upon when traffic laws are broken. APD uses STEP funding for officer overtime to patrol designated safety corridors, conduct saturation patrols and sobriety checkpoints, and enforce speeding laws. (State)

Title: New Mexico Gang Task Force

The New Mexico Gang Task Force (NMGTF) is the largest organized task force in the State dealing with gangs as a multi-jurisdictional, multi-agency entity. NMGTF's main goal is to provide federal, state, local and tribal agencies with training, information, and

funding to enhance interdiction and enforcement efforts with the goal of reducing criminal gang activity, including narcotics trafficking, throughout the State of New Mexico. APD has received a NMGTF sporadically in the last five years and uses these funds for anti-gang officer overtime. (Local)

Title: ATF TASK FORCE

The ATF Task Force grant will be used to pay overtime for officers to conduct investigations into violent crimes such as carjacking, commercial robberies, shootings, narcotics trafficking and previously convicted felons in possession of firearms. The ATF Task Force conducts proactive investigations in conjunction with field officers and detectives from various units within the department. **(Federal)**

Title: DEA Task Force Agreement

The Drug Enforcement Administration (DEA) is charged with the enforcement of the Controlled Substances Act as well as investigation of the highest level of domestic and international narcotics traffickers. With the direct cooperation of our state and local partners, the creation of the Task Force Program is one of the most productive ways that DEA enforces these laws. As drug trafficking increased nationwide, DEA recognized the need for cooperation and coordination of drug enforcement efforts with their state and local counterparts. (Federal)

Title: ENDWI

Operation ENDWI is statewide effort in which sobriety checkpoints are conducted throughout the state in every State Police District. When combined with Operation Buckle Down (safety belt use), the campaign is called a "SuperBlitz." SuperBlitzes are held for two weeks several times a year and are always combined with highly visible statewide and local publicity – using the messages -- You Drink. You Drive. You Lose. Or Click It Or Ticket. APD uses Operation DWI funding to provide for officer overtime. APD receives Operation DWI grant funds every year. (Federal Pass-through State)

Title: New Mexico Regional Computer Forensics Laboratory

With the proliferation of digital devices, today's criminal investigations often rely on evidence stored on computers, smart phones, and other connected tools. Performing digital forensic examinations on that evidence is the specialty of the New Mexico Regional Computer Forensics Laboratory (RCFL) program. Created in 2000, the program is a partnership between the FBI and other federal, state, and local law enforcement agencies operating a regional, digital forensic task force. The laboratories provide forensic services and expertise to support law enforcement agencies in collecting and examining digital evidence for a wide range of investigations, including child pornography, terrorism, violent crime, and fraud. The grant funds overtime for two officers to participate in this project. **(Federal)**

Title: Transnational Organized Crime West Task Force

Transnational organized crime (TOC) groups are self-perpetuating associations of individuals who operate, wholly or in part, by illegal means and irrespective of geography. They constantly seek to obtain power, influence, and monetary gains. To combat the ongoing threat posed by these groups, the FBI has a long-established transnational organized crime program dedicated to eliminating the criminal enterprises that pose the greatest threat to America. The grant will fund Task Force Officer overtime. (Federal)

Title: Violent Crimes Task Force

The purpose of this task force is to identify and target for prosecution criminal enterprise groups responsible for drug trafficking, money laundering, alien smuggling, cries of violence such as murder and aggravated assault. Funding will provide overtime for task force officers. (Federal)

Title: Game and Fish East

The grant will fund overtime to conduct specific enforcement patrols in identified areas to advance the Off-Highway (OHV) Act. The grant will pay for officer overtime, associated FICA, and IDOH. **(State)**

Title: Game and Fish West

The grant will fund overtime to conduct specific enforcement patrols in identified areas to advance the Off-Highway (OHV) Act. The grant will pay for officer overtime, associated FICA, and IDOH. **(State)**

Department: PARKS AND RECREATION

GRANTS WITH POSITIONS

The grant agreement with the NM ECECD in the amount of \$2,009,000 of which will fund 30 Part Time Employees. (State)

Title: 2022 New Mexico Early Childhood Education and Care Department, E Pre-K Program

The New Mexico Early Childhood Education and Care Department is distributing funds to the City of Albuquerque to provide Early Pre- Kindergarten for 44 eligible children at (3) City locations during the period of July 1, 2022 to June 30, 2023. The grant agreement with the NM ECECD in the amount of \$385,000 of which will fund 6 Part Time Employees. (State)

Title: 2022 New Mexico Early Childhood Education and Care Department

The New Mexico Early Childhood Education and Care Department is distributing funds to the City of Albuquerque the State of New Mexico's, as part of a grant from the U.S. Department of Agriculture (USDA) will fund the program cost for approximately \$1,232,608. This funding is used to operate a Food Service Program for children ages 1-18 years during the summer season when they are not in school. The project allows us the opportunity to provide nutritional assistance to children who reside in areas that

have been determined to be low-income. The program is a spin-off of the National School Breakfast and Lunch Program during the period of October 1, 2022 to September 30, 2023. Title: 2021-2022 4-H Park Burial Site Project

The City of Albuquerque is working with **WINDforce**, **Worldwide Indigenous Network of Diversity**, **an equity group within Salesforce**, to secure funds to support the research, re-design and development of a memorial at 4-H Park, the burial site associated with the old Albuquerque Indian School. The funding in the amount of \$850,000 will be used to support public input, tribal consultation, conceptual design, video documentation of the process, development of educational materials. The funding period begins April 2021 until completion. **(Private)**

GRANTS WITH POSITIONS

Title: State of New Mexico Litter Control and Beautification Grant

The State of New Mexico under the New Mexico Litter Control and Beautification Act makes grant funds available to New Mexico counties, cities and towns for the purpose of litter control and beautification. The grant funds four part time college intern positions working with the grant program managers. The grant benefits the City through its program activities, which include litter control, education program materials, landscape materials, school grounds improvements, resources recycling, teacher training, and youth probation supervision for litter removal. **(State)**

Department: Senior Affairs

GRANTS WITH POSITIONS

Title: Senior Companion Program

Created in 1974, the Senior Companion Program provides a way for volunteers age 55 and over to stay active by serving frail seniors and other adults, helping them to maintain independence in the client's home. Among other activities, Senior Companions assist with daily living tasks, such as grocery shopping and bill paying; provide

friendship and companionship; alert doctors and family members to potential problems, and provide respite to family caregivers. Senior Companions serve from 15 to 40 hours per week. The Corporation for National and Community Service (CNCS), the New Mexico Aging and Long-Term Services Department (NMALTSD), and the City of Albuquerque are the funding sources of the Senior Companion Program. (Federal and State Direct)

Title: Foster Grandparent Program (FGP)

The Corporation for National & Community Service (CNCS) provides federal funds directly to the City of Albuquerque Department of Senior Affairs to address the community's education needs. The FGP has been engaging senior volunteers in service as tutors and mentors to children with special and exceptional needs since 1965. In Albuquerque, FGP volunteers focus on children's academic improvements in K-12 and children's school readiness skills in head start and Pre-K. The majority of the grant funds stipend payments to income-eligible volunteers. The Department of Senior affairs also contracts with the New Mexico Aging & Long-Term Services Department for state funds to match the CNCS funds and for expansion. The City of Albuquerque annually appropriates city funds to further support the program and fund salaries and fringe benefits for three full time employees. (Federal Direct and State Direct)

Title: Retired and Senior Volunteer Program

RSVP is a volunteer network for people 55 years and older who are willing to use their lifetime skills to contribute and make our communities better. RSVP volunteers embrace the motto "Lead With Experience". Our goal is to recruit and facilitate the placement of volunteers in public, government and non-profit organizations. We aim to be the vital link that connects volunteer's lifetime of talents and experiences to the needs of our communities. RSVP volunteers can choose from a multiple list of opportunities that fall under registered Volunteer Stations. RSVP volunteers have the choice of receiving supplemental insurance and can be eligible for limited mileage reimbursements or bus pass reimbursements. RSVP volunteers do not have a required minimum of hours to serve however are expected to submit at least two hours every six months to remain active in the program. The Corporation for National and Community Service (CNCS), the New Mexico Aging and Long-Term Services Department (NMALTSD), and the City of Albuquerque are the funding sources of the Retired and Senior Volunteer Program. (Federal and State Direct)

Department: Albuquerque Fire Rescue

Title: Assistance to Firefighter Grant (AFG)

The AFG Program awards grants directly to fire departments, non-affiliated emergency medical services (EMS) organizations, and State Fire Training Academies (SFTAs) for the purpose of enhancing the health and safety of first responders and improving their abilities to protect the public from fire and fire-related hazards. 7/1/2022 - 6/30/2023 (Federal)

Title: EMS Act Fund, New Mexico Department of Health

The Emergency Medical Services Fund Act shall apply to requests made for funds available pursuant to the Emergency Medical Services Fund Act. The objective is to establish standards and procedures for regulating programs under the Emergency Medical Services Fund Act. These standards and procedures are designed for the purpose of making funds available to municipalities and counties, in proportion to their needs, for use in the establishment and enhancement of local emergency medical services in order to reduce injury and loss of life. This rule will inform New Mexico municipalities and counties of the procedures to access funds. The department of health, through the emergency medical systems bureau, will administer the fund pursuant to the Emergency Medical Services Fund Act and this rule. 7/1/2022 - 6/30/2023 (State)

Title: New Mexico Fire Marshall's Fire Protection Grant (FPG)

The New Mexico Public Regulation Commission is distributing funds to the City of Albuquerque to provide the City's first responders access to critical needs in the six categories. The six categories are Fire apparatus/equipment, Personal Protective Equipment (PPE), Communications, Facility construction/improvement, Training, Water and any need that will clearly have significant impact on Insurance Service Office (ISO) Public Protection Classification updated equipment, training and supplies. 7/1/2022 - 6/30/2023 (State)

Title: 2023 Waste Isolation Pilot Program (WIPP)

The New Mexico Resources and Energy Department distributing funds to the City of Albuquerque to render assistance to the development of a hazardous materials and radiological response program. 7/1/2022 - 6/30/2023 (Other)

Title: 2023 New Mexico Department of Homeland Security and Emergency Management-Hazardous Materials Emergency Preparedness (HMEP)

The U.S. Department of Homeland Security is distributing funds through the New Mexico Department of Homeland Security (NMDHSEM) to the City of Albuquerque to increase State, local, territorial and Native American tribal effectiveness to safely and efficiently handle hazardous materials accidents and incidents; enhance implementation of the Emergency Planning and Community Right-to-Know Act of 1986 (EPCRA); and encourage a comprehensive approach to emergency planning and training by incorporating response to transportation standards. Hazardous Materials Instructor Training Grant (HMIT): To "train the trainer" - that is, to train hazmat instructors who will then train hazmat employees in the proper handling of hazardous materials. Supplemental Public Sector Training Grants (SPST): to increase the number of hazardous materials training instructors, thereby increasing the number of training instructors available to conduct hazardous materials responder training programs for individuals with statutory responsibility to respond to hazardous materials accidents and incidents. Assistance for Local Emergency Response Training Grant (ALERT): to increase the number of emergency responders trained to respond to incidents or accidents involving the transportation of crude oil, ethanol and other flammable liquids by rail. Hazardous Materials Community Safety Grants (HMCS): to conduct national outreach and training programs to assist communities in preparing for and responding to accidents and incidents involving the transportation of hazardous materials, including Class 3 flammable liquids by rail; and train State and local personnel responsible for enforcing the safe transportation of hazardous materials, including Class 3 flammable liquids. 7/1/2022 - 6/30/2023 (Federal Pass-through State)

Title: 2023 U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Prevention, Harm Reduction Program Grant

The U.S. Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Prevention provides grants to support community-based overdose prevention programs, syringe services programs, and other harm reduction services. Funding is used to enhance overdose and other type of prevention activities to help control the spread of infectious diseases and the consequences of such diseases for individuals with, or at risk of developing substance use disorders (SUD), support distribution of Food and Drug Administration-approved overdose reversal medication to individuals at risk of overdose, build connections for individuals at risk for, or with, a SUD to overdose education, counseling, and health education, refer individuals to treatment for infectious diseases such as HIV, sexually transmitted infections, and viral hepatitis, and encourage such individual to take steps to reduce the negative personal and public health impacts of substance use or misuse. 5/30/2022 - 6/01/2024 (Federal)

Bus Stop Facilities Improvements 5307

The Transit Department desires to apply for \$500,000 in Federal Transit Administration (FTA) Section 5307 Formula Funds for Bus Stop Facilities Improvements. A local match totaling \$125,000 is available and is appropriated from the Transit Capital Implementation Program Fund 305 to Transit Grant Fund 665 and/or the Transfer to Capital Grants program in the Transit Operating Fund 661 to the Capital Grants Fund 665. Indirect costs in the amount of \$2,825 is included in the total grant amount and will be cost shared according to the FTA 5307 Formula rate of 80% by grantor and 20% local match.

This funding will provide funding for Transits Yale Transit Facility Renovation projects. **(Federal)**
