If appointed, Mr. Raynor would be filling a vacancy that occurred when Board Member Richard Johnson resigned. Mr. Raynor would complete a partial term and would be eligible for re-appointment for another three-year term.

Mr. Raynor is currently employed at Sandia National Laboratories as an electrical engineer. Like most engineers, he has a strong analytical and detailed mind which he feels will be a valuable asset to this board. The primary reason Mr. Raynor is seeking to serve on this Board is because he believes this type of service to our community will have a healing effect on all of us who live here. His desire to serve on the CPOA Board has its roots in a desire to provide a safer environment for his children, but he feels that it is something that he wants to see for everyone, and we should not have to wait until some distant time in the future to realize this dream. bridge that gap and be an impartial judge that tries to find the truth that lies somewhere in the middle.

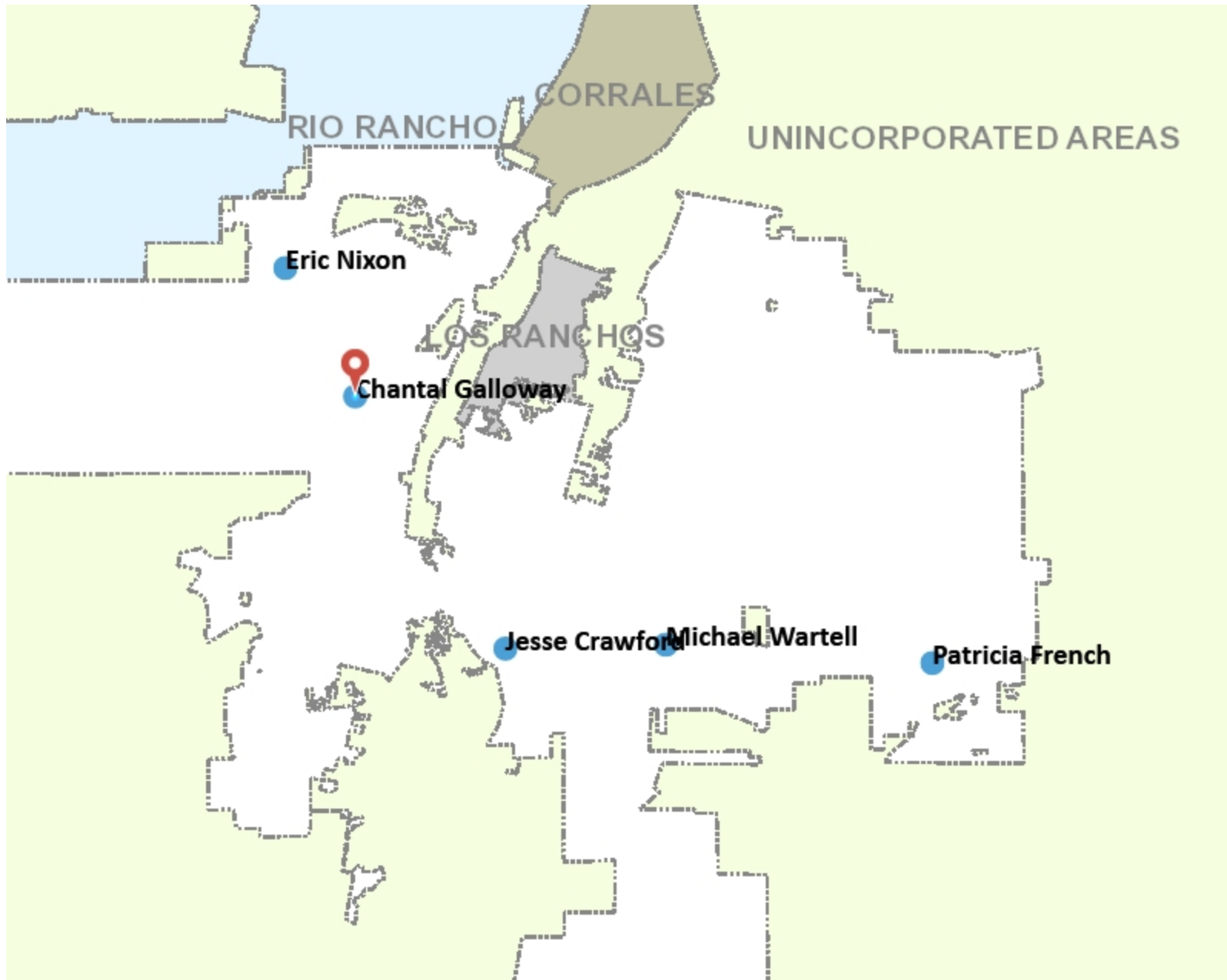
