WHEREAS, the Capital Implementation Program of the City of Albuquerque 6 is governed by the requirements established under Section 2-12-4 ROA, 1994, which 7 8 provides for amendments to the approved program; and 9 WHEREAS, the Council adopted Ordinance O-22-25 which authorized the 10 issuance and sale of a maximum amount of \$100,000,000 of City of Albuquerque, New Mexico Gross Receipts Tax Improvement Revenue Bonds Series 2022 for 11 12 various capital projects; and 13 WHEREAS, this resolution appropriates the bond proceeds anticipated from 14 the New Mexico Gross Receipts Tax Improvement Revenue Bonds Series 2022 to 15 project scopes for necessary projects in the City; and WHEREAS, establishing project scopes for these projects are timely and 16 17 necessary for the City to serve its citizens.
