Cover Analysis

1. What is it?

A Resolution is hereby submitted by the Parks and Recreation Department to accept grant funds for the “New Mexico People’s Garden” from U.S. Department of Agriculture/ Natural Resources Conservation Service (NRCS). The funds awarded to the City of Albuquerque total \$26,900 for fiscal year 2023 to install a new water meter, improve soil health, and increase storage.

2. What will this piece of legislation do?

This is an NRCS nationwide program that makes grants to improve community gardens. PRD has identified the Rey & Ilsa Garduno Agroecology Center as our top choice for the People’s Garden grant. The garden is located on City-owned land (Aviation Department) at the corner of Wellesley Ave, SE and Ross Ave SE. PRD and Aviation are partnering to improve this garden and this grant is a nice opportunity to invest in the site.

3. Why is this project needed?

The production of vegetables and fruit is important to small and large communities and urban neighborhoods lacking access to locally grown produce. Additionally, the development of greenspaces in urban areas beautifies communities and provides opportunities for community gathering. This agreement and partnership support USDA's interest in urban agriculture and the People’s Garden Initiative.

4. How much will it cost and what is the funding source?

The attached resolution from the Parks and Recreation Department authorizes a grant under U.S. Department of Agriculture/ Natural Resources Conservation Service (NRCS) funds. The funds awarded to the City of Albuquerque total \$26,900. Indirect Overhead (IDOH) of 6.2% is not applied.

5. Is there a revenue source associated with this contract? If so, what level of income is projected?

Approved expenses are to be reimbursed by U.S. Department of Agriculture/ Natural Resources Conservation Service (NRCS) funds.

6. What will happen if the project is not approved?

If this NM People’s Garden grant application is not approved, the major components of this agreement will not be achieved: 1) benefit the community, 2) be collaborative, 3) educate the community, and 4) incorporate sustainable practices.



Statement of Work

Purpose

The purpose of this agreement, between the U.S. Department of Agriculture, Natural Resources Conservation Service (NRCS) and the City of Albuquerque, is production of vegetables and fruits are important to small and large communities and urban neighborhoods lacking access to locally grown produce. Additionally, the development of greenspaces in urban areas beautifies communities and provides opportunities for community gathering. This agreement and partnership support USDA 's interest in urban agriculture and the People's Garden Initiative. To improve an existing garden or establish a new garden in the Albuquerque metropolitan area at The Rey and Ilsa Garduno Agro-Ecology Center, Corner of Wellesley Ave, SE and Ross Ave SE, Albuquerque, NM 87106 as a model People's Garden to benefit the local community.

Objectives

The People's Garden will include four components:

1. Benefit the community
2. Be collaborative
3. Educate the community
4. Incorporate sustainable practices

Budget Narrative

The official budget described in this Budget Narrative will be considered the total budget as last approved by the Federal awarding agency for this award.

Amounts included in this budget narrative are estimates. Reimbursement or advance liquidations will be based on actual expenditures, not to exceed the amount obligated.

1. Water meter to improve the garden's irrigation system: Badger Meter, Recordall Disc Meters Model 55-1in. with no installation at 1 each @\$10,000
2. Conex box to increase storage for tools and equipment for the garden 1 each @\$5,200. Storage would be a typical 10 ft. or 20 ft lockable container. Price will vary slightly new versus used and based on what is in stock.

Supplies Total: \$11,700.00

Contribute to larger projects that will improve soil health (\$11,700):

Approximately 100 cubic yards of all-natural, organic mulch/compost @\$102/cubic yard = \$10,200.00

$\$102.00 \times 100 = \$10,200.00$

Cost of plants that fix nitrogen and improve soil at 150 plants @\$10 per plant = \$1,500.00

$10.00 \times 150 = \$1,500.00$

Recipient has elected to voluntarily waive indirect costs.

When equipment is purchased with Federal funds it must be used until no longer needed as described in the General Terms and Conditions and 2 CFR 200. If the residual value of the equipment is \$5,000 or more at the time it is no longer needed, the recipient must request disposition instructions. The disposition instructions may direct the recipient to: 1) sell the equipment and return a proportionate share of the proceeds to the Federal agency; 2) transfer title to another eligible entity identified by the Federal agency; or 3) keep the equipment if desired and compensate the Federal agency for its proportionate share of the value.

Responsibilities of the Parties:

If inconsistencies arise between the language in this Statement of Work (SOW) and the General Terms and Conditions attached to the agreement, the language in this SOW takes precedence.

NRCS RESPONSIBILITIES:

- a) Provide technical assistance to plan and design the People's Garden.
- b) Participate in the public relations events to highlight conservation technical assistance and programs.
- c) Provide the garden with an official USDA People's Garden sign.

RECIPIENT RESPONSIBILITIES:

- a) Improve an existing garden or develop a new garden at the Corner of Wellesley Ave, SE and Ross Ave SE, Albuquerque, NM 87106.
- b) Ensure the garden meets the requirements for a People's Garden as outlined in the objectives of this agreement.
- c) Involve community participation in the development and ongoing operation of the garden, such as by providing volunteer opportunities to community members.
- d) Provide educational opportunities for the community, including programs about food production, food preparation, and/or environmental stewardship.
- e) Control/ownership of the land where the garden is to be located.
- f) Incorporate volunteers from the community to assist in the installation and maintenance of the garden and its supporting infrastructure, such as the raised beds, irrigation system, shed and greenhouse. Perform the work and produce the deliverables as outlined in this Statement of Work.

Comply with the applicable version of the General Terms and Conditions.

Submit reports and payment requests to the ezFedGrants system or the Farm Production and Conservation (FPAC) Grants and Agreements Division via email to FPAC.BC.GAD@usda.gov as outlined in the applicable version of the General Terms and Conditions. Limit advance payment requests to immediate cash needs (generally 30-60 days). Reporting frequency is as follows:

- Performance reports: Annual
- SF425 Financial Reports: Annual
- Submit payments request on a quarterly basis

Expected Accomplishments and Deliverables

The Recipient will improve or develop a People's Garden and maintain the garden through the life of this agreement. The Recipient will also use the garden to encourage community involvement and education.

Milestones:

Water meter installation, storage purchase, soil health materials delivered all before the end of the agreement 05/31/2023.

Summer 2022 – Much of the preliminary work can be accomplished without incurring expense. Work at the existing garden will be ongoing during the summer growing season and will not have to be disrupted.

Once the agreement is executed, the City of Albuquerque will begin the process of ordering supplies and equipment necessary to expand the existing community garden. (See budget narrative for specifics). After some work has begun, the City of Albuquerque will coordinate with the State Public Affairs Specialist for USDA/NRCS to coordinate a community wide ribbon cutting to official dedicate the People's Garden.

Fall and Winter 2022/Spring 2023 – Coordinate visits and educational outreach events for surrounding community members and other organizations.

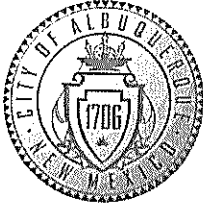

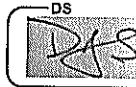

Subject: IDOH Waiver Request for NM People's Garden Project

The Parks and Recreation Department (PRD) is likely to be the recipient of a grant from the U.S. Department of Agriculture/Natural Resources Conservation Service (NRCS) for the "New Mexico People's Garden" project. This is an NRCS nationwide program that makes grants to improve community gardens.

PRD has identified the Rey & Ilsa Garduno Agroecology Center as our top choice for the People's Garden grant. The garden is located on City-owned land (Aviation Department) at the corner of Wellesley Ave, SE and Ross Ave SE. PRD and Aviation are partnering to improve this garden and this grant is a nice opportunity to invest in the site. NRCS has agreed to fund a \$26,900 grant that will install a new water meter, improve soil health, and increase storage.

Since this such a small grant, and PRD would like to utilize the full amount on garden improvements, PRD requests a waiver of the Indirect Overhead (IDOH). The current IDOH rate for PRD of 6.2% would result in a waiver of only \$1,668. If this project goes well, there is also a possibility of a second, larger NRCS grant for the garden and if that occurs, PRD would not object to the IDOH being applied to the larger grant amount.
