AND MAKING AN APPROPRIATION: 20 DIRECTING THE ADMINISTATION TO IDENTIFY MEANS TO ASSIST SOCIAL 21 SERVICE AGENCIES TO PROVICE TRANSIT PASSES. 22 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 23 **ALBUQUERQUE:** 24 WHEREAS, the City of Albuquerque operates ABQ Ride and Sun Van

Bernalillo County, providing millions of rides a year; and

Paratransit which tender transit services to the Citizens of Albuquerque and

WHEREAS, these services are a low-emissions and zero fare alternative
to automobiles for commuters, and are the primary means of transport for tens
of thousands of persons who qualify as "Transit Dependent' in Bernalillo
County by the Federal Transit Administration of the United States Department
of Transportation; and
WHEREAS, the City of Albuquerque initiated a system wide free fare transit
Pilot Project January 1st, 2022 that will expire on December 31, 2022; and
WHEREAS, according to the free fare transit report produced by the City,
the free fare program appeared to have resulted in a 25% increase in calls for
security service at bus stops and on buses in just the first quarter of 2022; and
WHEREAS, New Mexico's Attorney General's office reported that
shoplifters utilized city buses as their get-away vehicle. The Attorney General
believes this misuse of the transit system is the result of the free fare pilot
program, stating in a press interview; "I think that the no fee for riders seemed
like a well-intentioned policy, but there has to be safety requirements in other
words, you can't just let everyone on the bus with stolen equipment. "I'm very
concerned for families and the elderly that are doing no criminal activity but
now have to defend themselves' those precautions need to include
protecting bus drivers who are faced with this kind of behavior daily"; and
WHEREAS, since the inception of free fares, some motor coach operators
have left employment with the City citing safety concerns which further
exacerbates the driver shortage; and
WHEREAS, though free fare programs have been successful for a number
of transit agencies, other transit systems have experienced security
challenges. Anecdotal and official data from the Capital Transit System in
Austin, Texas suggest that lacking additional and robust security programs on
these two transit systems that problem riders increased substantially and
drove away other riders including regular bus commuters; and
WHEREAS, as with other transit agencies throughout the United States,

WHEREAS, as with other transit agencies throughout the United States, security on board ABQ Ride Coaches, Sun Van Paratransit Vehicles, at bus stops and at transit stations, is becoming of increasing concern, to both the drivers of transit vehicles and passengers. These concerns, if left unattended,

will overtime deter passengers from using transit and impede the recruitment and retention of motor-coach and paratransit vehicle operators; and

WHEREAS, an important management tool of public safety is the maintenance of high visibility facilities and equipment in prime condition to encourage patrons to use the asset constructively and not in a destructive manner. The Transit Department manages a large number of bus stops with benches, and bus shelters and ART Bus Stations. Providing premium maintenance for these stations is necessary to deter loitering and vandalism, and to promote comfort and enjoyment by the public; and

WHEREAS, it is imperative that the City of Albuquerque develop and implement a strategy to address security concerns on the transit system, including, creating near term, action plans to improve responses to incidents on transit vehicles, at bus stops and transit stations, better tracking and analyzing individual security incidents, security incident trends, and developing and implementing a long-term public transit safety strategy; and

WHEREAS, for these reasons the City should act proactively and the free fare pilot program should sunset before the end of the fiscal year 2023; and

WHEREAS, the City of Albuquerque's Transit Fare Schedule includes over 30 different fares. Simplifying the fare schedule to a few passes would improve access to transit as an alternative to the City's current walk-on free fare system. There would be multiple benefits to a pass system that helps provide accountability amongst riders while also offering the benefits of free fares; and

WHEREAS, for more than a decade the City Transit Department has been unable to staff a full complement of motor coach and paratransit van operators due to below market pay scales. In recent years the operator vacancy rate has reached twenty five percent, requiring the department to reduce the number of motor coaches serving bus routes, creating long wait times between bus arrivals, and diminishing the quality of the City's transit service; and

WHEREAS, for the success and long-term sustainability of the Albuquerque Transit System it is imperative the City establish competitive pay scales and a safe operating environment for motor-coach and paratransit van operators.BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

SECTION 1. Section 7-2-1-1 ROA 1994, "FARES AND PASSES," is amended

by deleting the existing language and inserting the following language:

16	name or photo identification card that is authorized to be used as transit fare
17	+]. Any person in violation of § <u>7-2-1-1</u> is guilty of a misdemeanor and subject
18	to the penalty provisions set forth in § 1-1-99 ROA 1994. Enforcement of § 7-2-
19	1-3 is suspended during the implementation of a 18 calendar month Zero Fare
20	Pilot."
21	SECTION3. A new Section §2-11-20 is created.
22	[+"(1) A separate program strategy for Motor Coach and Para-Transit
23	Operator Salaries and benefits shall be created within the Transit Enterprise
24	fund to be used only to increase salaries and benefits for Transit Motor Coach
25	and Para-Transit Operators. The program strategy shall be funded with ABQ
26	Ride and Sun Van Fare Revenues in addition to general fund revenues and
27	other sources as is applicable."+]
28	_SECTION 3. The Free Fare Pilot Program established in §7-2-1-2, will
29	conclude June 30th 2023 and the fare schedule established in §7-2-1-1, as
30	amended herein, will be reinstituted July 1st, 2023.
31	SECTION 4. The Administration shall by August 31, 2023, submit to
32	Council for its receipt an evaluation report on the "Free Fare Pilot Project".

The Department shall as technology becomes available 5 identify the feasibility of developing a fare-box pass system, that includes user photos on the pass, on fare box and pass card technology that enables the on 6 7 board farebox to record the time, date, route, transit vehicles, and boarding 8 location each time a pass is used to board an ABQ Ride motor-coach or Sun 9 Van paratransit vehicle. 10 SECTION 6. To address the increasing security issues on the City's Transit 11 and Paratransit System the City Administration shall develop a short-range 12 tactical plan, a long-range security program and a security incident tracking 13 system to respond to security calls for service on ABQ Ride motor coaches. 14 15 16 **17**

Sun Van paratransit vehicles, and at bus stops and transit stations. This effort shall be a collaborative effort amongst relevant City Departments, which may include but is not limited to, the Albuquerque Police Department, the Metro Security Division of the Department of General Services, the Albuquerque Transit Department, the Albuquerque Community Safety Department. The Bernalillo County Sheriff's Department shall be invited to participate in this initiative as the Transit Department operates routes in unincorporated Bernalillo County.

A. Tactical Plan. The tactical plan shall:

- a. Address all levels of calls ranging from low priority incidences to higher priority situations where health and safety are at risk for motor coach and van operators and passengers.
- b. Develop a procedure, to prevent access to transit by individuals who have been abusive or dangerous toward drivers or the public, on an ABQ RIDE motor-coach, a Sun Van paratransit vehicle, at bus stop, or a transit station, by causing them to lose access to transit for an appropriate period of time via a trespass citation or other appropriate means. The procedure shall also include a process for:

- i. Distributing to relevant Transit Department personnel a continually updated list of persons who have lost their access to the transit system. ii. A program for training Transit Department personnel on the procedures to follow when they encounter attempted bus usage by an individual who has lost their access. iii. A list of procedures for removing a person who has lost access from an ABQ Ride motor-coach, a Sun Van paratransit vehicle a bus stop or transit station or other facility.
 - c. The plan shall layout a process to most effectively utilize video and communications technologies currently embedded on the motor-coach and paratransit fleet to improve communications between the motor-coach operators, the Transit Department's Operations Center, and the Metro Security Division, the Albuquerque Police Department and Albuquerque Community Safety Department.

The tactical plan shall be communicated to the Director of the City Council Services Division through an Interoffice-Memo thirty days after the publishing of this Ordinance.

- B. Long Range Security Program. The Albuquerque Transit Department, the Albuquerque Police Department, the Metro Security Division of the Department of General Services, and the Albuquerque Community Safety Department with the assistance for the City Council Services Department shall conduct a study to develop a security program for the ABQ Ride Route system and the Sun Van systems, and the Transit Department's bus stops and transit stations. The study shall include the following objectives:
 - a. Identify best practices for transit security systems recommended by the Federal Transit Administration.
 - b. Provide a list of best practices used by transit agencies throughout the United States.

Department and the Albuquerque Transit Department shall, starting in

the 2nd quarter of Fiscal Year 23, compile on a quarterly basis, statistics on calls for security service to ABQ Ride motor-coaches, Sun Van paratransit vehicles, and the bus stops and stations of the Albuquerque Transit Department. The database shall include calls for service made to the Metro Security Division, the Albuquerque Police Department and the Albuquerque Community Safety Department. The data shall be categorized by the total number of calls for services by type of incident as classified in the Federal Bureau of Investigation's Uniform Crime Reporting System. The data shall also include the number and types of calls for service by route, including on motor-coaches, paratransit vans, bus stops and transit facilities. The data shall be communicated to the City Council by Executive Communication within 30 days of the conclusion of the quarterly reporting period.

Section 7. The Administration as part of its social service programing is directed to identify ways to assist social service agencies through funding or other means, in providing clientele with transit passes.

SECTION8. That the following amounts are hereby adjusted to the following programs and funds from fund balance, working capital balance, and/or revenue for operating City government in Fiscal Year 2023:

General Fund-110

Transfer to Transit Operating Fund-661

250,000

\$150,000 is designated for the purpose of funding the development of a fare pass distributors program as described in Section 3 of this Resolution, a Fare Pass and Fare Box Management Study as described in Section 4 of this Ordinance and a Transit Security Plan as described in Section 5 of this Ordinance.

SECTION9. SEVERABILITY CLAUSE. If any section, paragraph, sentence, clause, word or phrase of this ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this ordinance. The Council hereby declares that it would have passed this ordinance and each section,
