COUNCIL BILL NO. 0-22-35 ENACTMENT NO. 0-2022-034 SPONSORED BY: Pat Davis 1 ORDINANCE AMENDING THE CITY OF ALBUQUERQUE CODE OF ORDINANCES, SECTION 2 2-7-2-2, "AUTHORITY AND DUTIES OF THE CITY ATTORNEY" TO PROHIBIT 3 POLICY ADVOCACY BY THE CITY LEGAL DEPARTMENT. 4 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 5 6 ALBUQUERQUE: SECTION 1. Chapter 2, Article 7, Part 2, Section 2 of the Revised 7 Ordinances of Albuquerque, New Mexico, 1994, "Authority and Duties of the 8 City Attorney" is hereby amended as follows: 9 "§ 2-7-2-2 AUTHORITY AND DUTIES OF THE CITY ATTORNEY. 10 The City Attorney, both personally and through his or her assistant city 11 attorneys, shall represent the city in the courts. He or she shall also advise 12 the Mayor and the Council as to legal matters. The City Attorney and assistant 13 city attorneys, while acting in the course and scope of their duties, are 14 15 prohibited from engaging in policy advocacy relating to matters upon which the City Legal Department has or is likely to be called upon for advisement or 16 representation. Nothing herein shall prohibit the City Attorney or assistant 17 city attorneys from expressing their personal views on any issue while acting 18 19 outside the scope of their duties." SECTION 2. SEVERABILITY. If any section, paragraph, sentence, clause, 20 21 word, or phrase of this Ordinance is for any reason held to be invalid or unenforceable by any court of competent jurisdiction, such decision shall not 22 affect the validity of the remaining provisions of this Ordinance the Council 23 hereby declares that it would have passed this Ordinance and each section, 24 paragraph, sentence, clause, word, or phrase thereof irrespective of any 25 provision being declared unconstitutional or otherwise invalid. 26
