1 RESOLUTION
2 ESTABLISHING THE CITY COUNCIL'S BUDGET PRIORITIES AND
3 STRATEGIES FOR THE FISCAL YEAR 2024 OPERATING BUDGET AND THE
4 2023 GENERAL OBLIGATION PROGRAM.
5 WHEREAS, a city's budget is a statement of its values and priorities; and
6 WHEREAS, Article IV, Section 10 (b) of the Charter specifies that the
7 Albuquerque City Council shall annually review and adopt five-year goals and
8 one-year objectives for the City, which shall serve as the basis for budget
9 formulation and other policies and legislation; and
10 WHEREAS, City Council shall review, amend, and approve all budgets of
11 the City and adopt policies, plans, programs, and legislation consistent with
12 the goals and objectives established by the Council; and
13 WHEREAS, Article VII, Section 6 of the Charter specifies City Council shall
14 establish a procedure for formulation of the annual operating budget by
15 ordinance and adopted by the Council, after consultation with the Mayor,
16 consistent with the provisions of the City Charter; and
17 WHEREAS, on April 2, 2001, City Council unanimously adopted what
18 became Ordinance Enactment 16-2001 revising the budget ordinance to
19 incorporate the goals and objectives setting process for the City, and on April
20 25, 2001, it became law; and
21 WHEREAS, Ordinance Enactment 16-2001 identified eight city Goals
22 labeled Human & Family Development, Public Safety, Public Infrastructure,
23 Sustainable Community Development, Environmental Protection, Economic
24 Vitality, Community & Cultural Engagement, and Governmental Excellence &
25 Effectiveness; and

1 WHEREAS, on June 22, 2022, City Council unanimously approved a pilot
2 program to test and review a Priority-Based Budgeting process; and

3 WHEREAS, Priority-Based Budgeting focuses on setting budgetary
4 priorities, strategies, and identifying and ranking programs offered by the City
5 and the outcomes those programs produce; and

6 WHEREAS, the Council wishes to establish budgetary priorities and
7 strategies under the guidance of the eight City goals for the upcoming Fiscal
8 Year 2024 Operating Budget and the 2023 General Obligation Bond Program;
9 and

10 WHEREAS, the Council has identified six areas of budgetary priorities
11 labeled as Affordability & Housing, Safe Community, Multimodal
12 Transportation & Public Transit, Environmental Sustainability, Community
13 Vibrancy, and High Performing Governance; and

14 WHEREAS, the Council recognizes that while needs in communities in
15 each Council District are distinct, the budget can be used to invest in
16 programs and effect outcomes that raise the quality of life for residents in all
17 districts equally.

18 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
19 ALBUQUERQUE:

20 SECTION 1. BUDGET PRIORITIES. The City Council declares the budget
21 priorities listed below to be the Council's general priorities for the City's Fiscal
22 Year 2024 budget and their statements of intent. The Council commits to
23 working with the Mayor to enact these priorities in the Fiscal Year 2024
24 Operating Budget, and the 2023 General Obligation Bond Program (the listing
25 below is not exclusive of other potential City priorities and obligations, and
26 the order of the listing does not signify any ranking of importance amongst
27 priorities):

28 (A) BUDGET PRIORITY – AFFORDABILITY & HOUSING: Improve access
29 to a broad range of quality housing that is safe, accessible, and affordable.
30 Address the increase of the cost of living through diverse job opportunities,
31 living wage adjustments, and reduce the mismatch between available jobs and
32 skills in the workforce.

33 (B) BUDGET PRIORITY – SAFE COMMUNITY: Meet the expected level of

1 core and specialized public safety services as the community grows, and
2 continue to adapt and implement practices and strategies that address mental,
3 behavioral and illegal drug health issues.

4 (C) BUDGET PRIORITY – MULTIMODAL TRANSPORTATION & PUBLIC
5 TRANSIT: Building, maintaining and improving a modern infrastructure for
6 ease of traffic flow and safety, and the availability of transportation
7 alternatives, and access to public transportation.

8 (D) BUDGET PRIORITY – ENVIRONMENTAL SUSTAINABILITY: Ensuring
9 that the City’s bosque, open spaces and air quality are safe and clean for
10 recreation every day of the year by improving waste collection, reducing
11 dumping, increasing efficiency, and reducing energy use and greenhouse gas
12 emissions from City facilities and equipment.

13 (E) BUDGET PRIORITY – COMMUNITY VIBRANCY: Preserve the
14 community’s sense of place with a high value on natural areas, historic and
15 culturally important areas, culture, recreation, and park systems, and ensure a
16 robust, diverse, & sustainable economy.

17 (F) BUDGET PRIORITY – HIGH PERFORMING GOVERNANCE: Delivering
18 services desired by the community through sound financial management;
19 data-informed, transparent, and collaborative decision making; effective
20 communication and efficient project management; and attract and retain a City
21 workforce through development and growth opportunities.

22 SECTION 2. STRATEGIES. The City Council, after careful consideration of
23 the desired community conditions and outcomes, adopts the following
24 strategies for Fiscal Year 2024, grouped under the budgetary priorities listed
25 in Section 1 (the listing below is not intended to replace the City’s Annual One-
26 Year Objectives proposed by individual departments based on the City’s
27 goals; and the order of the listing does not signify any ranking of importance
28 amongst strategies).

29 **AFFORDABILITY & HOUSING:**

- 30 1) Build a youth center in cooperation with not-for-profit providers.
31 2) Ensure funding is adequate to support the Family and Community
32 Services Department in its efforts to address behavioral health, unhoused

1 individuals and families, and other wrap around services, including, but not
2 limited to funding for the Gateway Center.

3 3) Appropriate funding to renovate 50 affordable, public housing units;
4 and continue to provide safe, decent, physical and digitally connected
5 affordable housing options across the City through new developments and
6 redevelopment projects.

7 4) Ensure there is adequate investment in the Workforce Housing Trust
8 Fund, and that the use of the funds is diverse and not limited to LIHTC funded
9 projects.

10 **SAFE COMMUNITY:**

11 1) Support the Animal Welfare Department to open the spay/neuter
12 clinic to 5 days a week to reduce intakes and overcrowding at City shelters.

13 2) Support the modernization of the City's Eastside and Westside
14 Animal Shelters to improve the health and safety of animals, staff, and the
15 public.

16 3) Support the City's plan to have the Albuquerque Community Safety
17 Department (ACS) operate 24 hours/7 days a week.

18 4) Initiate a program to hire private security entities to assist in
19 patrolling public transit, public buildings, and neighborhoods.

20 5) Continue to prioritize full staffing and longevity incentives for APD
21 and AFR.

22 **MULTIMODAL TRANSPORTATION & PUBLIC TRANSIT:**

23 1) Prioritize multi-modal transportation, including, but not limited to,
24 additional walking and biking trails to encourage alternative modes of
25 transportation.

26 2) Continue to evaluate the City's Zero Fares Pilot Program, identify
27 and adopt any necessary changes, and provide funding to ensure security
28 needs for Public Transit are adequate.

29 3) Develop a comprehensive plan to move the City's public transit and
30 City fleet towards 100% electric.

31 **ENVIRONMENTAL SUSTAINABILITY:**

32 1) Update the Energy Conservation Code to include provisions for full
33 electrification of new and renovated buildings.

- 1 2) Take steps to implement the City's Climate Action Plan.
- 2 3) Expand energy efficiency services and programs for low-income
- 3 residents.
- 4 4) Continue to reduce energy use for City facilities.
- 5 5) Prioritize Open Space acquisition and development; and identify and
- 6 provide options to increase resources in the Open Space Trust Fund.

7 **COMMUNITY VIBRANCY:**

- 8 1) Increase funding available for a community development program for
- 9 Route 66/Central Avenue as approved in Resolution R-22-53; that promotes
- 10 and supports business incubation, activates underutilized spaces, and
- 11 rehabilitates and preserves historic signage and other historic assets.
- 12 2) Prioritize the beautification and maintenance of Route 66/Central
- 13 Avenue along the entire corridor to help spur economic development as
- 14 approved in Resolution R-22-53.

15 **HIGH PERFORMING GOVERNANCE:**

- 16 1) Develop and implement a \$15 minimum wage for all full-time, part-
- 17 time, and temporary City employees.
- 18 2) Complete the Classification and Compensation study funded in
- 19 Fiscal Year 2023 and identify and fund pay raises for skilled professionals in
- 20 City Departments that face chronic staffing shortages.
- 21 3) Increase compensation for facility maintenance staff including, but
- 22 not limited to, plumbers and electricians; and increase compensation for City
- 23 Planners, Engineers and other relevant jobs and professions in order to
- 24 remain competitive, to retain top talent and valuable institutional knowledge;
- 25 reduce vacant positions to reflect the number of highest priority positions that
- 26 can reasonably be hired within FY/24, and adjust appropriated amounts per
- 27 position to account for wage changes necessary to recruit and retain those
- 28 positions.
- 29 4) Continue to move salary positions funded through the Capital
- 30 Improvement Plan and Capital Projects Fund into the General Fund.
- 31 5) Update the Indirect Overhead (IDOH) Rate calculation and process
- 32 to remove charges for items that are pass-through projects and programs.

1 6) Prioritize full staffing for a variety of programs at City Senior
2 Centers, Multigenerational Centers, and Community Centers.

3 7) Prioritize full staffing for the Planning Department and review and
4 implement process improvements to streamline the construction permit
5 approval process.


6 **SECTION 3. APPROPRIATIONS.** The City Council directs the Administration




