At other times when it becomes Bracketed/Underscored Material - New 12 evident that the adopted list of regular meetings should be amended, this may 13 be done by resolution; such action should be taken as soon as it becomes Bracketed/Strikethrough Waterial] 14 clear that a change is appropriate."; and 15 WHEREAS, Article 1, Section 1 of the Council's Rules of Procedure 16 contains parallel provisions; and 17 WHEREAS, Resolution No. R-21-197, Enactment Number R-2021-069, set the dates for Council meetings through December 2022; and 18 WHEREAS, with the end of the calendar year approaching there is a need 19 20 to schedule the 2023 Council meeting dates. 21 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 22 ALBUQUERQUE: The official list of City Council regular meeting dates from January 2023 23 24 through December 2023 are as follows: 25 January 4 and 18; 26 February 6 and 22;
