1 RESOLUTION

2 APPROVING AND AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS
3 FROM THE NEW MEXICO ECONOMIC DEVELOPMENT DEPARTMENT AND
4 PROVIDING AN APPROPRIATION TO THE PARKS AND RECREATION
5 DEPARTMENT.

6 WHEREAS, the New Mexico Department of Economic Development has
7 been identified as the state agency responsible for distributing two-hundred
8 ninety-seven thousand and six-hundred dollars (\$297,600) of junior bill
9 funding for needed infrastructure on the Rio Grande Trail; and

10 WHEREAS, the legislative mandate behind the junior bill funding is for the
11 Outdoor Recreation Division to aid in the construction of shelters, restroom
12 facilities, drinking water infrastructure and other needed trail infrastructure on
13 the Rio Grande trail; and

14 WHEREAS, the Outdoor Recreation Division has selected eligible projects
15 in partnership with the Rio Grande Trail Commission and the Commission's
16 subcommittee on infrastructure; and

17 WHEREAS, the Rio Grande Trails Commission voted at its public meeting
18 on September 14, 2021, to approve funding for the selected infrastructure
19 projects. Based on that vote and the review of the infrastructure
20 subcommittee, the New Mexico Economic Development Department has
21 allocated one-hundred thousand dollars (\$100,000.00) to the City of
22 Albuquerque, Parks and Recreation Department; and

23 WHEREAS, the City of Albuquerque is desirous of accepting the funds.

24 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
25 ALBUQUERQUE:






