1 RESOLUTION

2 APPROVING AND AUTHORIZING A GRANT APPLICATION FROM THE
3 PETSMART CHARITIES AND PROVIDING AN APPROPRIATION TO THE CITY
4 OF ALBUQUERQUE ANIMAL WELFARE DEPARTMENT IN FISCAL YEAR
5 2023/2024.

6 WHEREAS, the PetSmart Charities wishes to grant the City of Albuquerque
7 \$60,000 to facilitate multiple efforts geared toward pathways to adoption; and

8 WHEREAS, the City of Albuquerque Animal Welfare Department will utilize
9 grant funds to facilitate pathways to adoption and adoption support, including
10 targeted advertising that grows awareness toward adoption, foster and
11 volunteer programs; adoption support for working cat adoptions, an exciting
12 and relatively new program at AWD that provides homes for otherwise hard to
13 adopt cats; and

14 WHEREAS, the City of Albuquerque Animal Welfare Department desires to
15 accept these funds, which require no City match or indirect overhead to
16 support this project.

17 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
18 ALBUQUERQUE:

19 Section 1. That the attached application for PetSmart Charities for the
20 amount of \$60,000 in grant funds is hereby approved, and its acceptance and
21 filling with the appropriate official or office is in all respects approved.


22 Section 2. That upon approval, funds in the amount of Sixty Thousand
