SUBJECT: Selection of the Director of Council Services

DATE: August 18, 2023

The Council Rules of Procedure, Article III, Section 21 state:

"Selection of the Director of Council Services. When a vacancy occurs in the position of Director of Council Services, the selection panel designated by and including the President of the City Council shall initiate recruitment, screening and interviewing of the candidates and shall submit the name of one qualified candidate to the full City Council for final selection. The Director of Council Services shall be selected by an affirmative vote of two-thirds of all Councilors."

The selection committee is making a recommendation to the full City Council that Mr. Isaac Padilla be the next Director of Council Services.
