The RFP was posted on the Purchasing E-Procurement, Bonfire website on March 31, 2023 and advertised in the Albuquerque Journal on April 3, 2023.

The City received one (1) responsive proposal to this solicitation. The ad hoc evaluation committee evaluated and scored the proposal in accordance with the evaluation criteria published in the RFP and recommends award to Fresquez Concessions Inc.

## **Cover Analysis**

#### 1. What is it?

The selected Offeror will provide a wide array of food and beverage concession options to meet the traveling public's demand for convenient, reasonably-priced, diverse food and beverage concession offerings at the Sunport.

## 2. What will this piece of legislation do?

The legislation will allow the Aviation Department to enter into an agreement with Fresquez Concessions Inc. to operate a twelve (12) unit food and beverage concession at the Sunport.

## 3. Why is this project needed?

The previous concessions lease agreements have expired and are currently under a two (2) year extension. This award will allow for the execution of a new twelve (12) year agreement with the company to operate twelve (12) units.

## 4. How much will it cost and what is the funding source?

The build-out of the shell spaces for these units and all remaining concessions units (to be addressed under subsequent award processes) are covered by the Aviation Department's ongoing \$87M Dream of Flight renovation project, which is paid for directly via the department's enterprise funding stream.

5. Is there a revenue source associated with this contract? If so, what level of income is projected?

Once completed, Aviation believes that concession revenues to the City will increase by \$200,000 a year.

#### 6. What will happen if the project is not approved?

If the RFP is not awarded, the City cannot negotiate the lease with the company and the Sunport will not be able to operate a food and beverage program for the traveling public.

#### 7. Is this service already provided by another entity?

The service is currently being provided by Fresquez Companies operating under a two (2)year contract extension.
