After graduating law school and passing the New Mexico bar, Heidi has focused extensively on policy impacting tribes, including Indian education, tribal affairs, and education in general. Heidi has worked with the American Indian Law Center, the NM Indian Affairs Department, the Legislative Education Study Committee, the NM Public Education Department, and One Generation.

A non-city resident, Heidi MacDonald will be appointed on the Commission and serve as the education representative; their term will expire on October 1, 2026.
