1 RESOLUTION

2 ESTABLISHING FEDERAL PROGRAMMING AND POLICY PRIORITIES FOR  
3 THE CITY OF ALBUQUERQUE FOR FEDERAL FISCAL YEARS 2024/2025.

4 WHEREAS, the residents of Albuquerque share common aspirations,  
5 ambitions, and purposes that form the goals, missions, and responsibilities of  
6 the City of Albuquerque; and

7 WHEREAS, the City of Albuquerque, the State of New Mexico and the  
8 Government of the United States of America form the commonwealth through  
9 which these aspirations are expressed, pursued and fulfilled in our  
10 community; and

11 WHEREAS, it is in the interest, and the desire of, the City of Albuquerque  
12 for the Federal Government to continue with and expand programs that assist  
13 local governments to improve public safety, behavioral and public health,  
14 housing, indigent care, services for the disabled, protection of the natural  
15 environment, improve and maintain critical infrastructure, and help foster  
16 sustainable economic development; and

17 WHEREAS, the appropriations committees of the Second Session of the  
18 118<sup>th</sup> Congress of the United States, are anticipated to call for project funding  
19 requests for the Community Project Fund and Congressionally Directed  
20 Spending measures to fund public infrastructure and community-based  
21 service programs for State and Local Government; and

22 WHEREAS, the City Administration and the City Council through research  
23 and due diligence have identified a list of federal priorities that best utilize the  
24 resources and funding programs of the Federal Government to improve the  
25 health, safety, and welfare of the residents of Albuquerque; and

1 WHEREAS, the City of Albuquerque Intergovernmental Legislative  
2 Relations Committee convened December 27<sup>th</sup> of 2023 and approved a list of  
3 projects to be submitted to the City Council as the City of Albuquerque's  
4 Federal Priorities for Federal Grant and Congressionally Directed Funding.  
5 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF  
6 ALBUQUERQUE:

7 SECTION 1. To further provide for the health, safety, welfare and quality of  
8 life of its residents, the City of Albuquerque entreats the Federal Government  
9 to create policies and programs that strengthen and expand the City's  
10 responsibilities to its residents that:

- 11 • Protects the rights of all citizens.
- 12 • Fosters and preserves equity and social justice by implementing  
13 policies and programs inclusive of all persons so as to utilize the vast  
14 potential present in the diversity of our citizens.
- 15 • Develops and expands behavioral health and public safety services  
16 that better provide health care and substance abuse services, reduce  
17 recidivism through the courts and correctional system, address the needs of  
18 the unhoused, offer housing assistance and mental health care, create  
19 services for the physically and mentally disabled, and institute family, child  
20 and senior care services.
- 21 • Provides funding for community policing services that develop a  
22 working relationship between the citizens who serve as police officers and the  
23 citizens they serve, so as to provide public safety that is effective, just,  
24 equitable, and built on trust and understanding and to support the shared  
25 missions between police services and mental health and social service  
26 agencies.
- 27 • Creates a sustainable economy that generates opportunities for  
28 entrepreneurs and existing businesses while providing living wages, a safe  
29 work environment, health insurance, sick leave, and retirement benefits for  
30 employees.
- 31 • Fosters a co-existence with the natural environment to ensure a  
32 sustainable water supply, clean air, the conservation of open spaces, water

1 courses, protection of wildlife, and mitigation of the impacts of climate  
2 change.

3 • Provides all citizens access to art, civic engagement, culture,  
4 entertainment, history and literature.

5 • Invests in infrastructure that supports and sustains the health,  
6 housing, transportation, and ecological systems critical to sustaining a  
7 community.

8 SECTION 2. The City of Albuquerque encourages the New Mexico  
9 Congressional Delegation to advocate for the programs listed in the  
10 Attachment to this Resolution.

11 SECTION 3. That this Resolution be presented and delivered to members  
12 of the Congressional Delegation.

### Congressional Support of Programs that Support City of Albuquerque Mission Objectives

#### **Behavioral Health**

- Short-and long-term addiction prevention rehabilitation and sobriety assistance.
- Data collection of populations needing behavioral health and indigent care.
- Facility development for centers that assist indigent and homeless persons.
- Services for families requiring crisis assistance.
- Inter-agency continuum of care initiatives.
- Provision of basic living needs.
- Recidivism reduction.

#### **Education**

- Early childhood education Head Start Program.
- Funding for community 5G and wi-fi infrastructure.
- STEM training programs for low- and moderate-income populations.
- Workforce training in key and developing industry clusters for minority populations.

#### **Economic Development**

- Assistance with job development at transportation hubs including aviation facilities.
- Economic development planning.
- Emerging industries facility development including re-use of vacant or partially used commercial and industrial structures.

- Affordable housing development via the low-income housing tax credit program.
- Continuation and expansion of eviction protection voucher programs.
- Continue to provide adequate funding for federal programs that assist housing low- and moderate-income households, including the Housing and Urban Development Choice Planning and Implementation Grant program, Community Development Block Grants, etc. to expand the capacity of state and local housing programs.
- Regulations to improve access to fair housing by housing voucher recipients.
- Improving funding for low-income home weatherization programs.
- Infrastructure funding for low-income communities.
- Mortgage and rent assistance.
- Pandemic related eviction assistance program.

- Expand funding for the Environmental Protection Agency small and disadvantaged communities drinking water grant program.
- Expand the United States Army Corps of Engineer's program to provide funding for the construction of water and stormwater systems in underserved low-income communities.
- Expand funding for the Federal Emergency Management Agency's disaster mitigation grants program to serve low-income underserved communities.
- Increase funding for the Community Development Block Grant program.

- *Space Technology Hub*: Continue support of the development of missions at Kirtland Air Force Base that further the development of the Albuquerque economy as a Renewable Energy and Space Technology Hub.

- Expand funding for Medicaid in-House Substance Abuse Treatment Programs.

#### **Public Health**

- Funding for local agencies to address public health needs.

### Requests for New Federal Policy Priorities and Programs

#### **Behavioral Health**

- *Data Sharing:* Adopt legislation supporting the sharing of federal data with state and local agencies as well as organizations working to end homelessness, reintegrating previously incarcerated citizens back into the community, and ending the cycle of hospitalizations.

#### **Consent Decree Assistance**

- Create grant programs to assist police agencies under a federal consent decree to implement the recommendations and required improvements issued through the consent decree.

#### **Economic Development**

- *Local Tourism Grants:* Create grant programs for communities to develop local tourism, including facility development and entrepreneur and workforce training.
- *Small Business Technical Assistance:* Adopt legislation creating programs to fund technical assistance programs that aid small businesses to establish capacity building, including information technology systems, data management, utility burden management, and other systems necessary for operating a business in the 21<sup>st</sup> century.
- *Space Technology Hub:* Expand support of federal programs that further space technology development, the transfer of military technology to civilian use, and assisting metropolitan areas in developing the infrastructure to support space technology.

#### **Education**

- *Unhoused Children Education:* Adopt legislation creating a program to provide communities with resources to offer quality education services to unhoused children, including both on-site and remote-learning opportunities.
- *Learning Technologies Low Income Students:* Adopt legislation creating a grant program to provide remote learning technologies to children who reside in families with low- and moderate-income.

### Requests for New Federal Policy Priorities and Programs

#### **Equitable Access To Transportation And Infrastructure**

- *Affordable 5G*: Create a grant program to ensure that internet infrastructure, including wi-fi and 5G technology, are affordable and available to all persons, especially those least able to access services, including the homeless and the indigent.
- *Low-Income Neighborhoods Basic Infrastructure*: Create grant programs to provide roads, transit and utilities to underserved low-income communities.
- *Non-Fuel Revenue Transportation Funding*: Diversify the funding stream for the federal highway and transit programs to adjust to revenue losses due to declining Federal Gas Tax revenues.
- *Security Practices*: Create a program to fund research and development into security practices for transit systems and create grant programs to provide operating funds for security operations at transit agencies.
- *Transit Fares*: Funding for Transit Zero Fares and motor coach driver training and retention.

#### **Environmental Protection**

- *Carbon Emission Reduction*: Create programs for local and state government agencies to reduce carbon emission from their facilities and fleets to help reduce carbon emissions by 2050 to levels that stave off the worst of climate change.
- *National Pollutant Discharge Elimination System (NPDES) Permit Compliance*: Create grant programs to assist local agencies in implementing best practices and infrastructure projects to comply with the requirements established in the “Regional Storm Water Discharge Permit”.

#### **Support Senate Bill 2286 Streamlining Federal Grants Act.**

- *Urging the New Mexico Congressional Delegation to Support Senate Bill 2286 “Streamlining Federal Grants Act”*: Standardize and coordinate grant administration across the federal government to make it easier for communities and organizations to apply for grants.

#### **Immigration Reform**

- *Humane Immigration Reforms*: Enact immigration reforms that provide immigrants with rights that respect their human dignity and status as taxpayers and contributing members of the community.
