R-24-27 ENACTMENT NO. **SPONSORED BY: Tammy Fiebelkorn, by request** 1 RESOLUTION 2 ADOPTING AN UPDATED ALBUQUERQUE/ BERNALILLO COUNTY 3 **COMPREHENSIVE PLAN.** WHEREAS, the City Council, the Governing Body of the City of 4 5 Albuquerque, has the authority to amend and adopt the Comprehensive Plan 6 as authorized by State statute, Section 3-19-9, NMSA 1970, and by its home 7 rule powers established by the New Mexico State Constitution; and 8 WHEREAS, the City's planning and zoning powers are established by the 9 City charter, in which: Article I, Incorporation and Powers, allows the City to 10 adopt new regulatory structures and processes and implement the Bracketed/Strikethrough Material] - Deletion 11 Albuquerque/Bernalillo County Comprehensive Plan ("Comp Plan") guiding Bracketed/Underscored Material] - New 12 future legislation; Article IX, Environmental Protection, empowers the City to 13 adopt regulations and procedures to protect and preserve environmental 14 features such as water, air and other natural endowments, ensure the proper 15 use and development of land, and promote and maintain an aesthetic and 16 humane urban environment; and Article XVII, Planning, establishes the City 17 Council as the City's ultimate planning and zoning authority, including 18 adoption of the Comp Plan; and 19 WHEREAS, the Comp Plan is the Rank 1 Plan for the physical development 20 and conservation of areas within the City of Albuquerque and unincorporated 21 Bernalillo County, which sets out the context, goals and policies, monitoring 22 and implementation, and supporting information to further its vision and 23 purpose; and 24 WHEREAS, the City Council adopted an update to the 25 Albuquerque/Bernalillo County Comprehensive Plan in 2017 via R-16-108

1	WHEREAS, the City Council directed the City to update the
2	Albuquerque/Bernalillo County Comprehensive Plan in August 2022 via R-22-
3	42 (Enactment No. R-2022-061); and
4	WHEREAS, the proposed update to the Comp Plan incorporates visions,
5	goals, and policies from other City plans and reports completed since the last
6	update to the Comp Plan in 2017, including the Age-Friendly Action Plan (R-
7	21-221, Enactment No. R-2022-008), the Climate Action Plan (EC-21-378), the
8	Vision Zero Year-in-Review and Prioritization report (EC-23-376), and
9	Community Planning Area Assessment Reports (R-22-42); and
10	WHEREAS, the update to the Comp Plan adds language for clarity, updates
11	narratives for consistency with current programs and practices, and updates
12	maps and graphics to reflect current conditions in the City; and
13	WHEREAS, the update to the Comp Plan tracks progress toward
14	implementing Comp Plan policies by updating the Implementation Policy
15	Action Matrix to provide greater transparency and accountability for
16	responsible departments; and
17	WHEREAS, an update of the Comp Plan provides an opportunity to apply
18	best practices for land use, transportation, and preservation and strategies for
19	regional, interagency transportation and land-use planning; and
20	WHEREAS, an update of the Comp Plan helps protect the public health,
21	safety, and welfare; and
22	WHEREAS, an update to the Comp Plan provides an opportunity to foster
23	increased collaboration and coordination between City of Albuquerque
24	departments and partnering agencies by tracking progress toward regional
25	goals and policies for healthy growth, efficient transportation, infrastructure
26	needs, and development to reflect new market demands, diversify and bolster
27	the economy, better serve all constituents, support efforts to grow and
28	develop in sustainable ways, respect and preserve natural and cultural
29	resources, and improve the quality of life for all residents; and
30	WHEREAS, the Integrated Development Ordinance requires a
31	Comprehensive Plan Amendment to be reviewed and recommended by the
32	Environmental Planning Commission and decided as a legislative action by
33	City Council [§14-16-6-7(A)(2)(c)]; and

1	WHEREAS, the City provided all required notice for a Comprehensive Plan
2	Amendment, including publishing a legal ad in the Albuquerque Journal,
3	emailing two representatives of each neighborhood organization registered
4	with the Office of Neighborhood Coordination (ONC), and posting notice on
5	the Planning Department website; and
6	WHEREAS, the City provided additional notice on a project webpage and
7	emails to approximately 9,500 subscribers on January 10, 2023; and
8	WHEREAS, though a Pre-submittal Neighborhood Meeting is not required
9	for a Comprehensive Plan Amendment, Council staff held six (6) public review
10	meetings in October and November 2023 to present and discuss the proposed
11	changes to the Comp Plan, respond to questions, and gather feedback; and
12	WHEREAS, the City advertised the public review meetings through multiple
13	social media posts; and
14	WHEREAS, the EPC held a public hearing on January 18, 2024 and found
15	that the proposed amendments satisfy the review and decision criteria for an
16	Amendment of Comprehensive Plan in IDO §14-16-6-7(A)(3) and forwarded to
17	the City Council a recommendation of approval, subject to findings and
18	recommended conditions that are in the record as the Notice of Decision; and
19	WHEREAS, Council staff has incorporated the proposed updates to the
20	Comp Plan along with the EPC recommended conditions of approval into a
21	redline draft for review by City Council.
22	BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
23	ALBUQUERQUE:
24	SECTION 1. The Albuquerque/Bernalillo County Comprehensive Plan is
25	amended as shown in Exhibit 1 (EPC Redline Draft) as recommended by the
26	EPC, except as modified by amendments adopted subsequently in Section 2
27	and/or Section 3 below.
28	SECTION 2. The Albuquerque/Bernalillo County Comprehensive Plan is
29	amended from Exhibit 1 (EPC Redline Draft) by Committee Amendments
30	approved by the City Council's Land Use, Planning, and Zoning (LUPZ)
31	Committee, as shown in Exhibit 2 (LUPZ Committee Amendments).
32	SECTION 3. The Albuquerque/Bernalillo County Comprehensive Plan is
33	amended from Exhibit 1 (EPC Redline Draft) and/or from Exhibit 2 (LUPZ

	3	SECTION 4. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
	4	clause, word or phrase of this resolution is for any reason held to be invalid or
	5	unenforceable by any court of competent jurisdiction, such decision shall not
	6	affect the validity of the remaining provisions of this resolution. The Council
	7	hereby declares that it would have passed this resolution and each section,
	8	paragraph, sentence, clause, word, or phrase thereof irrespective of any
	9	provisions being declared unconstitutional or otherwise invalid.

The attached, recommended legislation would adopt text and map amendments to the Albuquerque/Bernalillo County Comprehensive Plan.

BACKGROUND

Council Resolution R-22-42 adopted on August 15, 2022 (Enactment No. R-2022-061) directed the City to update the Albuquerque/Bernalillo County Comprehensive Plan.

The last update to the Comp Plan was adopted in March 2017 and included a matrix of actions to implement policies within each Comp Plan Element (i.e., Community Identity, Land Use, Housing, etc.). This action matrix, included in Section 14.4 of the plan, identified the timeline (e.g., short-term, medium-term, long-term, or ongoing), lead department(s), and coordinating departments/agencies.

The 2023 update is intended to track progress on these actions since 2017 and include narratives and policies identified in parallel planning efforts completed since 2017.

REQUEST

This request is for an amendment to the Albuquerque/Bernalillo County Comprehensive Plan with a limited scope. The primary purpose of this update is to report progress on actions taken by various City departments since 2017 to implement Comp Plan Goals and Policies. This update also incorporates new actions and policies identified in parallel planning efforts since 2017, namely the Vision Zero Action Plan, the Age Friendly Action Plan, the Climate Action Plan, and Community Planning Area Assessments. This update does not propose changes to

growth projections or demographics.

While no change is proposed to the methodology to create the map of Development Areas, this update does include a new Areas of Change / Consistency map that results from rerunning the methodology. The updated map reflects new Metropolitan Redevelopment Areas adopted since 2017 and zoning map amendments approved since 2017.

Maps of citywide public facilities have been updated to reflect new fire and police stations, parks, and recreation facilities.

NOTIFICATION

Pursuant to the Integrated Development Ordinance, the required notice for Comp Plan amendments must be published, emailed, and posted on the web. The City published the required notice in the newspaper and sent email notice to two representatives of each registered neighborhood organization. Mailed notice was sent to neighborhood representatives without email addresses, as required, and web notice was posted on the Planning Department website and on the Comp Plan project website: https://compplan.abq-zone.com/comp-plan-update-2023.

In addition to the required notice, information about the proposed Comp Plan update was advertised on Instagram, X (formerly Twitter), and LinkedIn, and emailed to the Planning Department distribution list of approximately 9,500 subscribers.

Staff received few comments expressing support or opposition and recommending changes; however, there is general support for the request as a whole.

EPC PROCESS

The Environmental Planning Commission (EPC) reviewed the proposed amendments during the properly-noticed public hearing. On January 18, 2024, the EPC heard the staff presentation, took public comment, considered recommended conditions, and voted to forward a recommendation of Approval to the City Council. The Official Notification of Decision for the request contains the EPC's findings and recommended conditions.

CONCLUSION

Regarding Project #PR-2023-009664, RZ-2023-00052, Amendment to the Albuquerque/Bernalillo County Comprehensive Plan, the EPC is forwarding a recommendation of Approval, subject to conditions.

A redline draft of the Albuquerque/Bernalillo County Comprehensive Plan that incorporates the EPC's conditions is included with this transmittal of the record for the Council's consideration.

1. What is it?
