1 ORDINANCE

2 AMENDING SECTION 7-11-5(H) ROA 1994, THE FINE SECTION OF THE SAFE
3 TRAFFIC OPERATIONS PROGRAM, TO REDUCE FINES FOR RUNNING A RED
4 LIGHT.

5 BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
6 ALBUQUERQUE:

7 Section 1. Section 7-11-5(H) ROA 1994 of the City's STOP Ordinance
8 (ENFORCEMENT) is hereby amended to read as follows

9 "(H) Fine. The date of a violation is the effective date. If the registered
10 owner or nominee requested a hearing and did not prevail, the date of the
11 violation is the effective date. ~~[-The fine for the first violation for running a red~~
12 ~~light is \$100-].~~ [+There shall be no fine for a first violation for running a red
13 light but an individual shall still be found to have committed a violation and
14 shall have the same right to notice and to contest such violation as if subject
15 to a fine.+] The fine for a second violation for running a red light within two
16 years from the date of the first violation is ~~[-\$250-]~~ [+\$69.00+]. The fine for a
17 third or subsequent violation for running a red light within two years from the
18 date of the first violation is ~~[-\$500-]~~ [+\$150+]. The fines for speeding are as
19 follows:

20 (1) Up to and including ten miles per hour over the speed limit: ~~[-~~
21 ~~\$100-]~~ [+ A warning+].

22 (2) From 11 up to and including 15 miles per hour over the speed
23 limit: ~~[-\$150-]~~ [+\$89.00+].

24 (3) From 16 up to and including 20 miles per hour over the speed
25 limit: ~~[-\$200-]~~ [+\$124.00+].

1 (4) From 21 up to and including 25 miles per hour over the speed
2 limit: ~~[-\$250-]~~ [\$159.00+].

3 (5) From 26 up to and including 30 miles per hour over the speed
4 limit: ~~[-\$300-]~~ [\$184.00+].

5 (6) From 31 up to and including 35 miles per hour over the speed
6 limit: ~~[-\$350-]~~ [\$209.00+].

7 (7) More than 35 miles per hour over the speed limit: ~~[-\$400-]~~
8 [\$259.00+].

9 The Mayor may promulgate regulations instructing the Department to waive
10 fines for minimum speed violations from time to time in specific locations.
11 The fine for any violation not listed above shall be \$500.”

12 Section 2. SEVERABILITY CLAUSE. If any section, paragraph, clause or
13 provision of this Ordinance shall for any reason be held to be invalid or
14 unenforceable, the invalidity or unenforceability of such section, paragraph,
15 clause or provision shall not affect any of the remaining provisions of this
16 Ordinance.

17 Section 3. EFFECTIVE DATE. This Ordinance shall take effect five days
18 after publication by title and general summary.

19 Section 4. COMPILATION. Section 1 of this Ordinance shall be
20 incorporated in and made part of the Revised Ordinances of Albuquerque,
21 New Mexico, 1994.
