1 **ORDINANCE** 2 ADOPTING A UNIFORM ADMINISTRATIVE CODE AND TECHNICAL CODES 3 PRESCRIBING MINIMUM STANDARDS REGULATING THE CONSTRUCTION, 4 ALTERATION, MOVING, REPAIR AND USE AND OCCUPANCIES OF 5 BUILDINGS AND STRUCTURES AND BUILDING SERVICE EQUIPMENT AND INSTALLATIONS INCLUDING PLUMBING, SWIMMING POOLS, ELECTRICAL, 6 7 MECHANICAL, SIGNS, SOLAR, ENERGY CONSERVATION, 8 CONSERVATION AND THE ABATEMENT OF DANGEROUS BUILDINGS WITHIN 9 THE CITY OF ALBUQUERQUE: PROVIDING FOR THE ISSUANCE OF PERMITS 10 AND COLLECTING FEES THEREFORE; REPEALING CHAPTER 14, ARTICLE 1, -Bracketed/Strikethrough Material-] - Deletion 11 ROA 1994, THE PRESENT UNIFORM ADMINISTRATIVE CODE, AND THE +Bracketed/Underscored Material+] - New 12 PRESENT TECHNICAL CODES INCLUDING THE BUILDING CODE, THE 13 PLUMBING CODE, THE SWIMMING POOL CODE, THE MECHANICAL CODE, 14 THE SOLAR ENERGY CODE, THE ELECTRICAL CODE, PROVIDING FOR 15 PENALTIES FOR VIOLATION OF THE CODE: PROVIDING A SEVERABILITY 16 CLAUSE; PROVIDING THE EFFECTIVE DATE AND PROVIDING FOR 17 PUBLICATION. BE IT ORDAINED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF 18 19 **ALBUQUERQUE:** 20 Section 1. INTENT OF ORDINANCE. It is the intent of this ordinance that 21 the City shall recover from fees derived from Building and Safety 100% of the 22 full cost, including indirect charges of code enforcement activities. It shall be 23 the responsibility of the Mayor to review the Building and Safety income at 24 yearly intervals and to recommend to the Council the need to increase or

- 1 Section 2. ADOPTION OF THE UNIFORM ADMINISTRATIVE CODE OF THE 2 CITY OF ALBUQUERQUE. The Uniform Administrative Code is hereby 3 adopted and shall serve as the administrative, organizational and enforcement 4 rules and regulations for the adopted technical codes within the City of
 - Section 3. ADOPTION OF THE TECHNICAL CODES OF THE CITY OF For the purpose of prescribing minimum standards ALBUQUERQUE. regulating construction and maintenance of buildings and structures, including all building service equipment, and installations within the City of Albuquerque, New Mexico, the following codes are hereby adopted:
- 11 The New Mexico Building Code as adopted by the Construction 12 Industries Division of the State of New Mexico with an effective date of July 1, 13 2004;
- 14 (B) The 2003 International Building Code as adopted by the Construction 15 Industries Division of the State of New Mexico, including Appendix Chapters 16 B, C, E, H, I, and J, with an effective date of July 1, 2004;
 - (C) The 2003 International Residential Code as adopted by the Construction Industries Division of the State of New Mexico, including Appendix Chapters H, K with an effective date of July 1, 2004;
 - The 2003 New Mexico Earthen Building Materials Code as adopted by the Construction Industries Division of the State of New Mexico with an effective date of July 1, 2004;
 - (E) The 2003 New Mexico Historic Earthen Building Code as adopted by the Construction Industries Division of the State of New Mexico with an effective date of July 1, 2004;
 - The 2003 New Mexico Existing Building Code as adopted by the (F) Construction Industries Division of the State of New Mexico with an effective date of July 1, 2004;
- 29 (G) The 2003 New Mexico Non-Load Bearing Straw Construction 30 Building Standards as adopted by the Construction Industries Division of the 31 State of New Mexico with an effective date of July 1, 2004;

 - The 2005 New Mexico Electrical Code as adopted by the (0)Construction Industries Division of the State of New Mexico with an effective date of July 1, 2005;
 - (P) The 2002 New Mexico Electrical Safety Code as adopted by the Construction Industries Division of the State of New Mexico with an effective date of July 1, 2004;
 - (Q) Errata sheets to the adopted portions of the Codes promulgated by the International Code Council, International Association of Plumbing and **Mechanical Officials and National Electrical Code**;
 - (R) The City of Albuquerque amendments to the New Mexico Codes referred to herein are set forth as Exhibit A and incorporated by reference are hereby adopted and together with the Codes in divisions (A) through (Q) of this section shall be known as the Uniform Construction Codes of the City of Albuquerque. From the date on which this ordinance takes effect they shall be

- 1 controlling within the municipal boundaries of the City of Albuquerque, New 2 Mexico.
 - Section 4. AMENDMENTS TO THE UNIFORM CODES OF THE CITY OF ALBUQUERQUE. The Uniform Codes of the City of Albuquerque hereby adopted may be amended or repealed in the same manner as ordinances are amended or repealed.
 - Section 5. AVAILABILITY OF THE UNIFORM CONSTRUCTION CODES OF THE CITY OF ALBUQUERQUE. A copy of the Uniform Administrative Code and a copy of the Uniform Construction Codes of the City of Albuquerque as adopted by this ordinance are on file in the Office of the City Clerk of the City of Albuquerque, and are available for inspection by the public during regular business hours. A copy of said codes shall be available to any individual upon request and the payment of a reasonable charge as set by the Chief Administrative Officer, to be not less than the actual cost per copy.
 - Section 6. BUILDING AND SAFETY DIVISION - JURISDICTION. The Building and Safety Division of the Planning Department shall have jurisdiction to administer the Uniform Construction Codes of the City of Albuquerque for construction, alteration, moving, demolition, repair, use and occupancy of buildings, structures and building service equipment.
 - Section 7. FIRE MARSHAL JURISDICTION; APPLICATION OF FIRE CODE.
 - The Fire Marshal shall have jurisdiction under the Fire Code of the (A) City of Albuquerque to test and inspect fire alarm systems and fire suppression systems, including fire hydrants, fire extinguishers and sprinkler systems installed in construction, alteration, moving, repair, demolition, use and occupancy of buildings, structures and building service equipment. The Fire Marshal shall have jurisdiction under the Fire Code as adopted by the Fire Department of the City of Albuquerque as applicable to construction, alteration, moving, demolition, repair, use and occupancy of buildings, structures and building service equipment.
 - (B) **Existing Buildings.** The Fire Marshal shall have jurisdiction to administer the Fire Code of the City of Albuquerque as applicable to all existing structures.

Section 8. CONFLICT OF CODES. When a conflict exists in specific code requirements between applicable sections of the Uniform Construction Codes of the City of Albuquerque and the Fire Code of the City of Albuquerque, the **Uniform Construction Codes shall prevail.**

Section 9. PENALTIES. Any person violating any of the provisions of this code or failing or neglecting to comply with any orders issued pursuant to any section thereof shall be deemed guilty of a misdemeanor and such person shall be guilty of a separate offense for each and every day or portion thereof during which any such violation is continued or permitted. Upon conviction of any such violation, such person shall be punished by fine of not more than \$500 or by imprisonment for not more than 90 days, or by both such fine and imprisonment.

Section 10. REPEALER. Ordinance No. 56-1999 and No. 58-2004, adopting the Uniform Administrative Code, the Building Code, the Mechanical Code, the Plumbing Code, the Swimming Pool Code, the Solar Energy Code, the Electrical Code, and all amendments thereto, which is compiled as Chapter 14, Article 1 of the Revised Ordinances of Albuquerque, New Mexico, 1994; are hereby repealed; provided, however, that nothing contained in this ordinance shall, in any manner, affect pending actions for violations of Ordinance No. 56-1999 or No. 58-2004 or the Codes incorporated therein as such actions shall be governed by Ordinance No. 56-1999 and No. 58-2004 and the Uniform Administrative and Construction Codes incorporated therein.

Section 11. SEVERABILITY CLAUSE. If any section, subsection, sentence, clause, word or phrase of this ordinance is for any reason held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council, the Governing Body of the City of Albuquerque, hereby declares that it would have passed this ordinance and each section, subsection, sentence, clause, word, or phrase thereof irrespective of any one or more sections, subsections, sentences, clauses, words, or phrases being declared unconstitutional or otherwise invalid.
