1 **RESOLUTION**

2 **APPROVING AND AUTHORIZING THE FILING OF THE ATTACHED GRANT**
3 **APPLICATION FOR A PROJECT SAFE NEIGHBORHOODS PROGRAM FROM**
4 **THE NEW MEXICO DEPARTMENT OF PUBLIC SAFETY AND PROVIDING FOR**
5 **AN APPROPRIATION TO THE CITY OF ALBUQUERQUE, POLICE**
6 **DEPARTMENT.**

7 **WHEREAS, the City of Albuquerque has as one of its goals to enhance**
8 **local law enforcement efforts thereby providing for the public safety and**
9 **welfare; and**

10 **WHEREAS, the City of Albuquerque is committed to creating safer**
11 **neighborhoods by reducing gun violence and gun crime and sustaining that**
12 **reduction; and**

13 **WHEREAS, the City of Albuquerque is committed to funding a Violent**
14 **Crime Impact Team (VCIT) to reduce firearms-related violent crime; and**

15 **WHEREAS, grant funds in the amount of \$11,5000 will be used to pay**
16 **officers overtime to execute ten (10) suppression/apprehension operations;**
17 **and**

18 **WHEREAS, the City of Albuquerque is desirous of accepting these funds**
19 **for which indirect costs of \$675 and FICA charges of \$167 are required to**
20 **support this grant and are available in the FY/08 Transfer to Operating Grants**
21 **Fund Program in the General Fund.**

22 **BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF**

3 Section 2. That upon award, funds in the amount of \$11,500 from the New
4 Mexico Department of Public Safety and indirect costs of \$675 and FICA
5 charges of \$167 from the Fiscal Year 2008 Transfer to Operating Grants Fund
6 Program in the General Fund are hereby appropriated to the Albuquerque
7 Police Department in the Operating Grants Fund, 265, for Fiscal Year 2008 and
8 2009.
