1 RESOLUTION

2 APPROVING AND AUTHORIZING A MEMORANDUM OF AGREEMENT WITH
3 THE NEW MEXICO DEPARTMENT OF HEALTH FOR THE WEST NILE VIRUS
4 SURVEILLANCE AND DATA MANAGEMENT PROGRAM AND MAKING AN
5 APPROPRIATION TO THE ENVIRONMENTAL HEALTH DEPARTMENT.

6 WHEREAS, the City of Albuquerque has as one of its goals to ensure an
7 environment which is adequate to protect the public health and safety of
8 present and future generations; and

9 WHEREAS, the City is striving to eliminate or reduce the probability of
10 exposure to West Nile Virus and other mosquito-borne diseases; and

11 WHEREAS, the operation of the Vector Borne/Zoonotic Disease Division of
12 the Environmental Health Department provides the technical means of
13 accomplishing these goals; and

14 WHEREAS, the New Mexico Department of Health has awarded funding for
15 fiscal year 2008; and

16 WHEREAS, Congress has provided the Centers for Disease Control with
17 special funding to address requirements for surveillance and data
18 management of the West Nile Virus and will make this funding available for
19 Fiscal Year 2008; and

20 WHEREAS, the New Mexico Department of Health will fund this program
21 and not require the City of Albuquerque to match any part of the funding; and

22 WHEREAS, the funds must be appropriated to continue the effort to
23 conduct surveillance for the West Nile Virus and other mosquito-borne
24 diseases.

25 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
26 ALBUQUERQUE:

1 Section 1. That the attached draft Memorandum of Agreement No.
2 09/665.0300.07628 between the City of Albuquerque and the New Mexico
3 Department of Health is hereby approved, and the Mayor is authorized to take
4 all necessary and appropriate action to implement the contract agreement.

5 Section 2. That funds in the amount of eighteen thousand dollars
6 (\$18,000), of which one thousand two hundred and forty four dollars (\$1,244) is
7 for the City indirect costs, is hereby appropriated to the Environmental Health
8 Department for the Arbovirus Surveillance program in the Operating Grant
9 Fund (265) for fiscal year 2008.
