2 **NAMING THE FITNESS CENTER OF LOS VOLCANES SENIOR CENTER, "JOE O.**  
3 **ARMIJO SENIOR FITNESS CENTER."**

4 **WHEREAS, Joe Armijo dedicated his time to the lives and well being of the**  
5 **Senior Citizen's of Albuquerque; and**

6 **WHEREAS, Mr. Armijo served his community through his appointment by**  
7 **Mayor Chávez and the Albuquerque City Council as a member of the Department**  
8 **of Senior Affairs Advisory Board for nearly ten years; and**

9 **WHEREAS, Mr. Armijo served as President of the Department of Senior**  
10 **Affairs Advisory Board, committing his time to enhance the lives of the senior**  
11 **citizens of Albuquerque; and**

12 **WHEREAS, Mr. Armijo and his wife Mary Lou Vau Armijo shared their time**  
13 **with other seniors at Los Volcanes Senior breakfasts almost every morning; and**

14 **WHEREAS, Mr. Armijo served his Country in World War II and was a**  
15 **member of the Knights of Columbus, the New Mexico Court Association, and the**  
16 **New Mexico Officials Association; and**

17 **WHEREAS, Mr. Armijo was a devoted husband and father to his 11**  
18 **children, and a devoted grandfather to his 29 grandchildren and 15 great**  
19 **grandchildren; and**

20 **WHEREAS, Mr. Armijo participated in senior activities with his wife at Los**  
21 **Volcanes Senior Center and also participated in the Ribbon Cutting Ceremonies**  
22 **for Los Volcanes Fitness Center in July 2008; and**

23 **WHEREAS, the family of Joe O. Armijo, the senior citizens of Los Volcanes**  
24 **Senior Center, the senior citizens of Albuquerque, and the community of City**  
25 **Council District One lost a good friend and public servant on April 10, 2009; and**

7 to the senior citizens of his community and the City of Albuquerque.

8 Section 2. That a plaque bearing the name “Joe O. Armijo Senior Fitness  
9 Center” shall be prominently placed on the Fitness Center at Los Volcanes Senior  
10 Center.
