**1 RESOLUTION**

**2 REQUESTING THE ADMINISTRATION TO ISSUE A REQUEST FOR  
3 PROPOSALS FOR SERVICES OF A LEAD WASHINGTON REPRESENTATIVE  
4 FOR THE CITY OF ALBUQUERQUE, AND URGING THE ADMINISTRATION TO  
5 CONSIDER WORKING WITH OTHER LOCAL ENTITIES INCLUDING THE  
6 ALBUQUERQUE BERNALILLO COUNTY WATER UTILITY AUTHORITY,  
7 BERNALILLO COUNTY, AND THE MID-REGION COUNCIL OF GOVERNMENTS  
8 TO INVESTIGATE THE ADVANTAGES OF SHARING THE COST OF SUCH  
9 SERVICES.**

**10 WHEREAS, the City of Albuquerque has historically used the services of a  
11 lobbyist in Washington, D.C. to assist with furthering the City's federal  
12 program and to advise City leaders with regard to federal issues and funding;  
13 and**

**14 WHEREAS, the City of Albuquerque has retained the services of a lead  
15 Washington representative for over 20 years; and**

**16 WHEREAS, the City has not sought proposals for the lobbyist position  
17 during that 20 year period; and**

**18 WHEREAS, the City's current federal lobbyist is also under separate  
19 contracts with other local governmental agencies such as the Albuquerque-  
20 Bernalillo County Water Utility Authority, the County of Bernalillo and the Mid-  
21 Region Council of Governments; and**

**22 WHEREAS, the City's contract with the current lobbyist will expire on June  
23 30, 2011; and**

**24 WHEREAS, a request for proposals will allow the City to determine if City  
25 resources are being used in the most effective way possible.**
